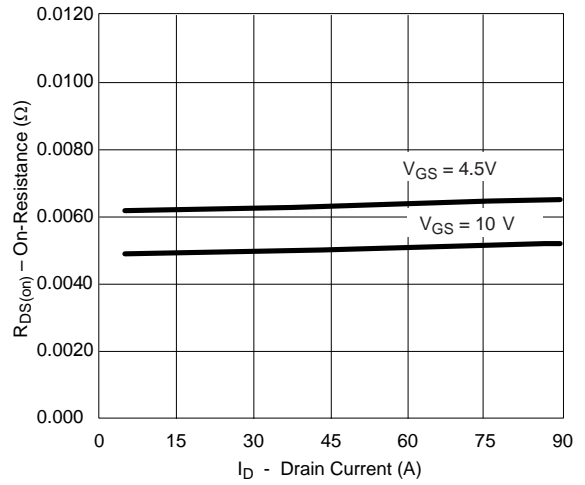

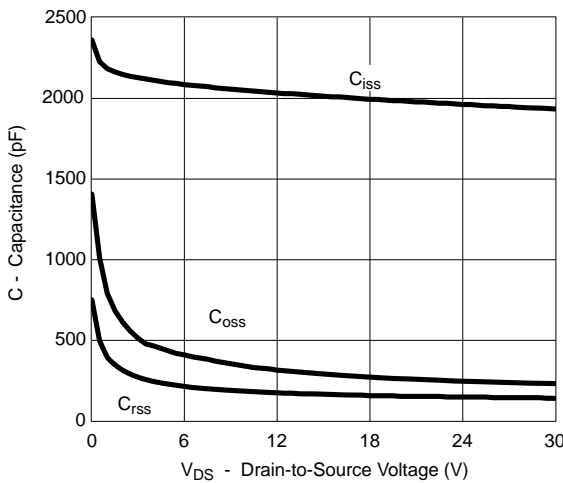

Capacitance

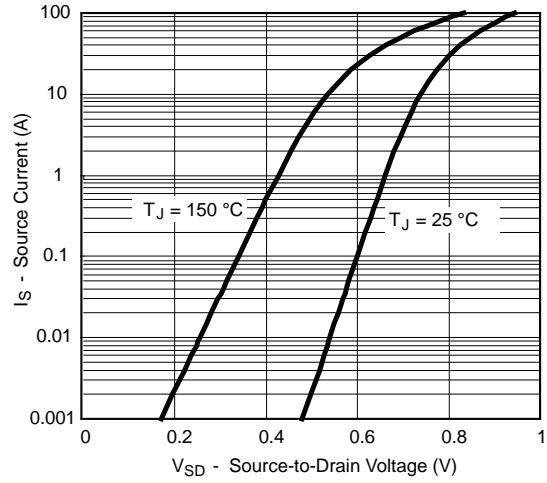

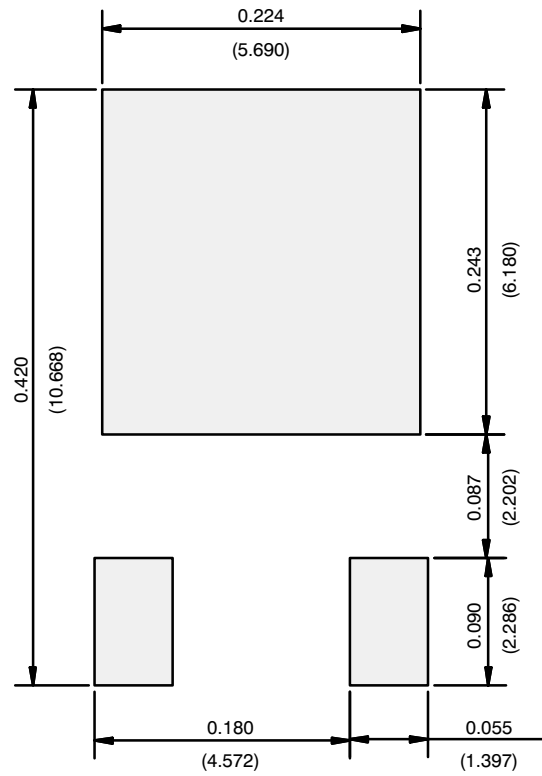
