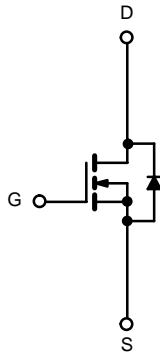

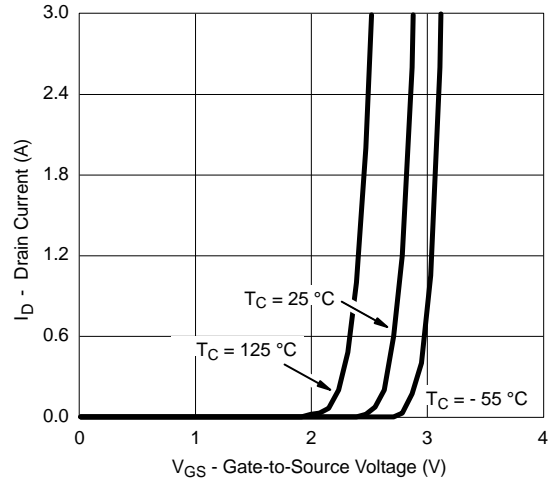

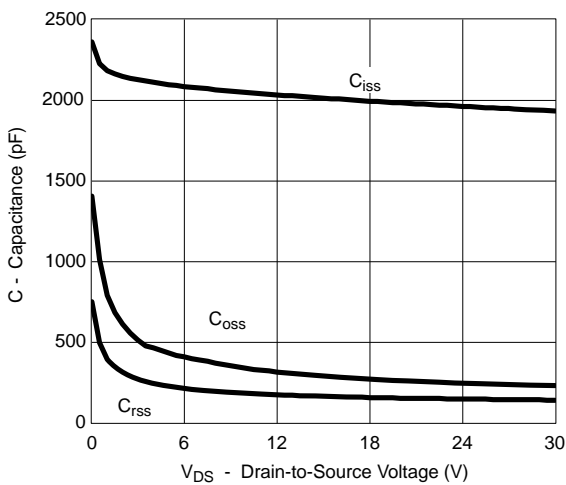

$R_{DS(on)}$ vs. Drain Current

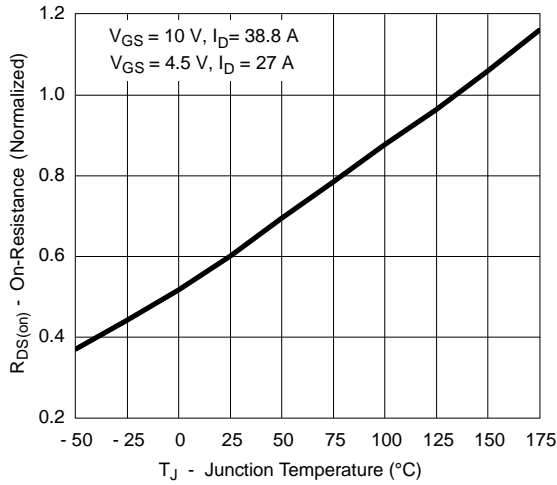

$R_{DS(on)}$ vs. V_{GS} vs. Temperature

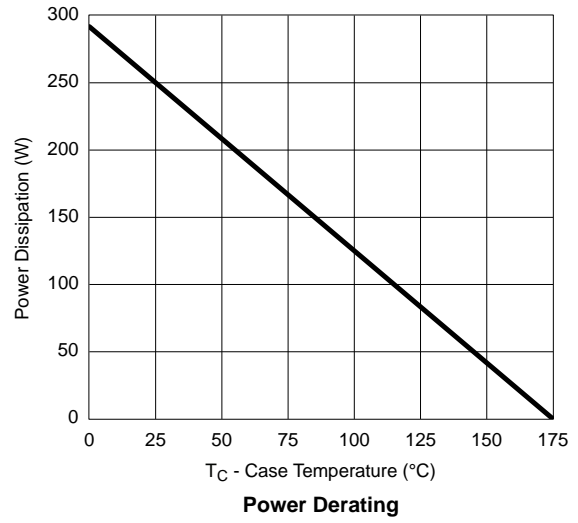
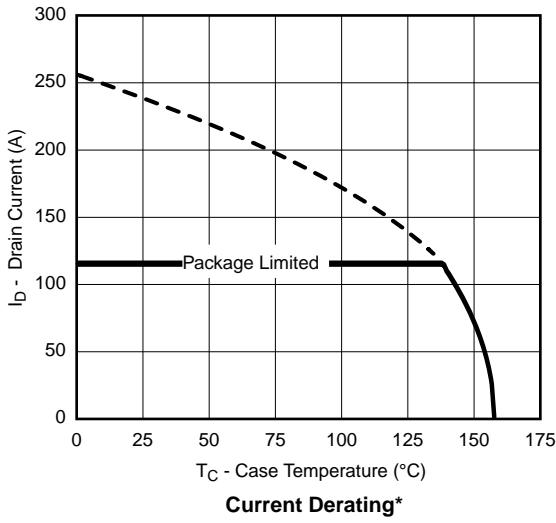

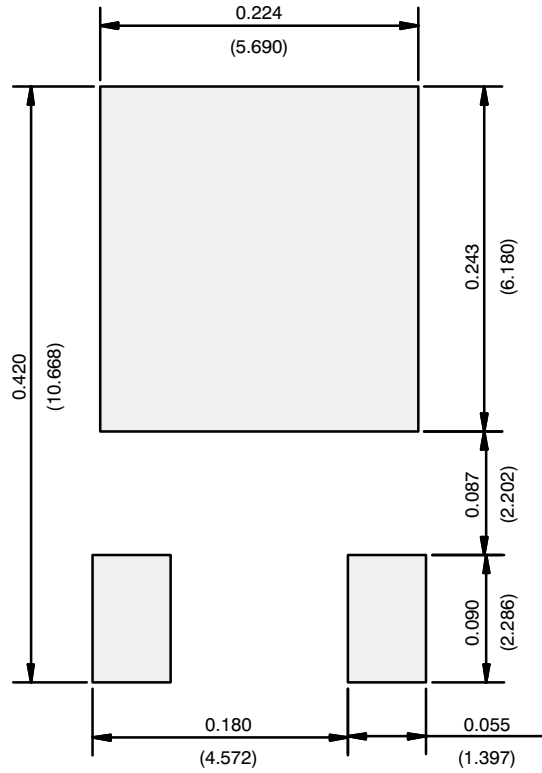
