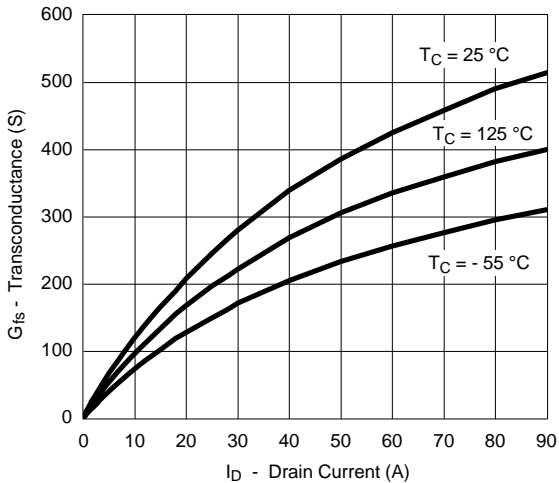

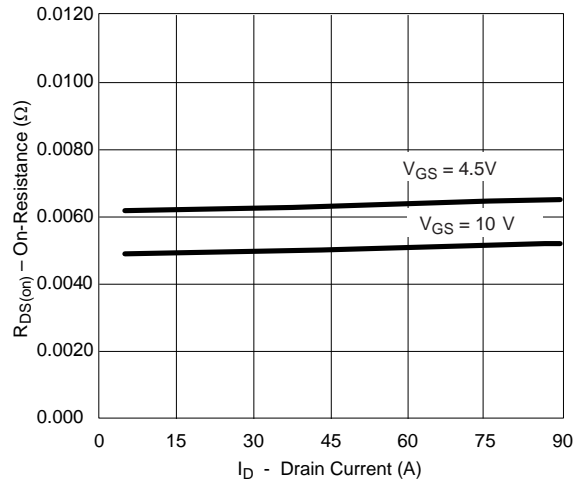

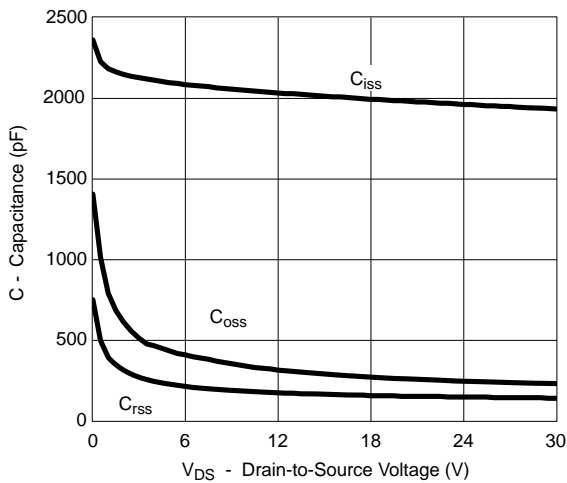

Capacitance

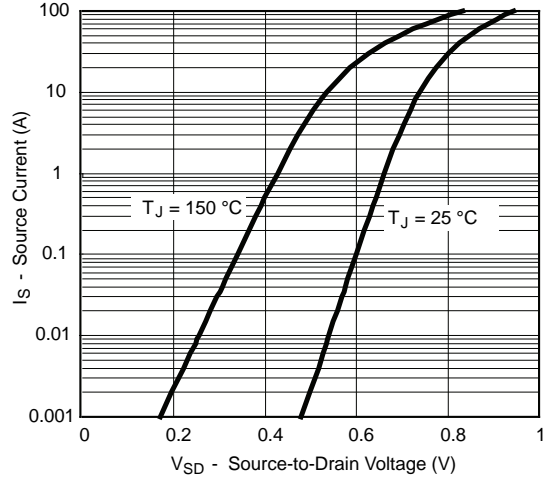

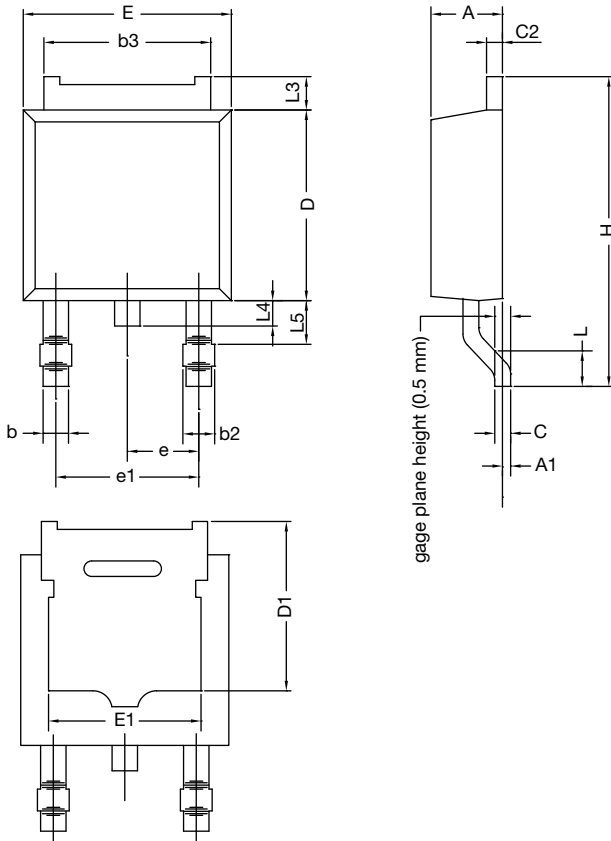

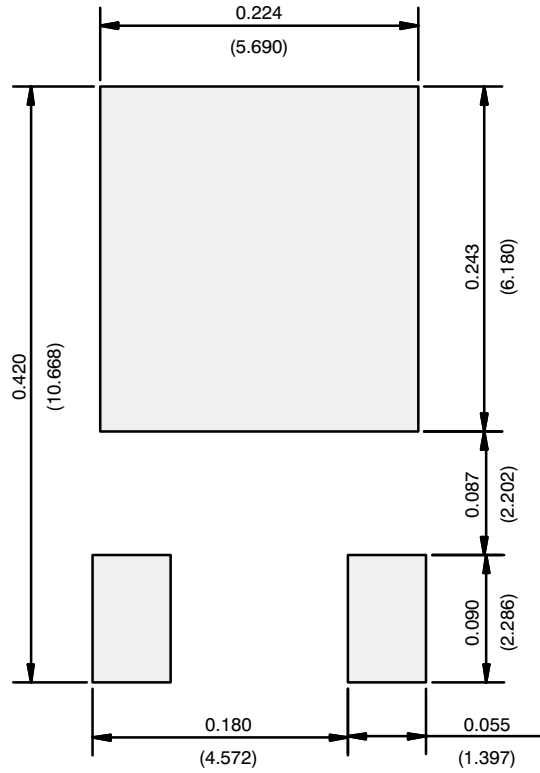
