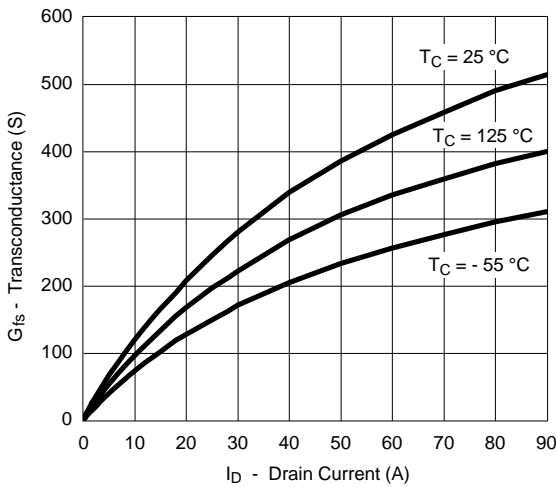

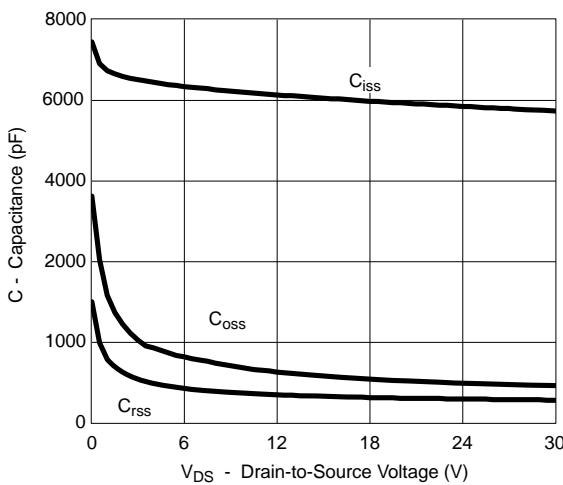

R_{DS(on)} vs. V_{GS} vs. Temperature

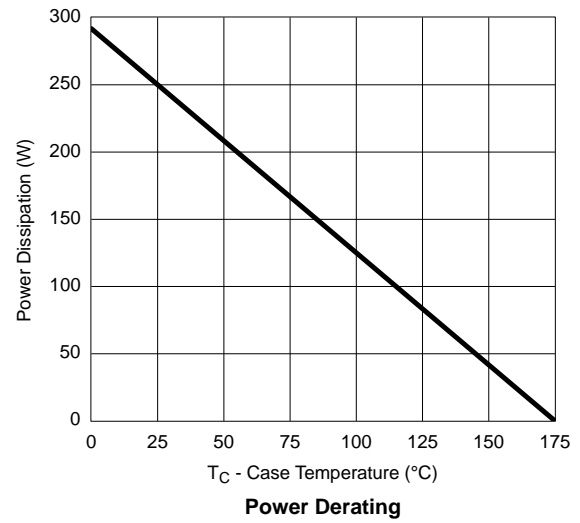
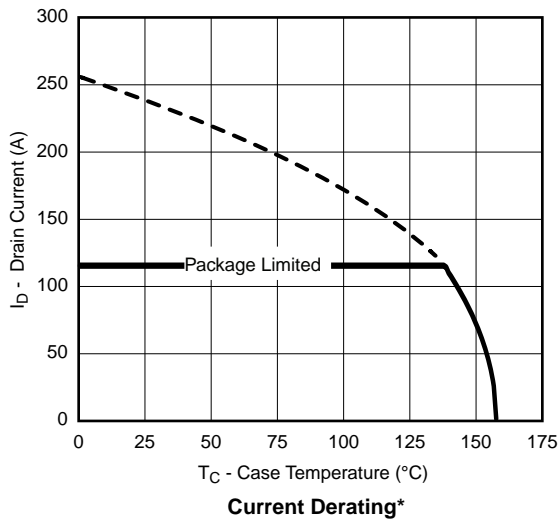

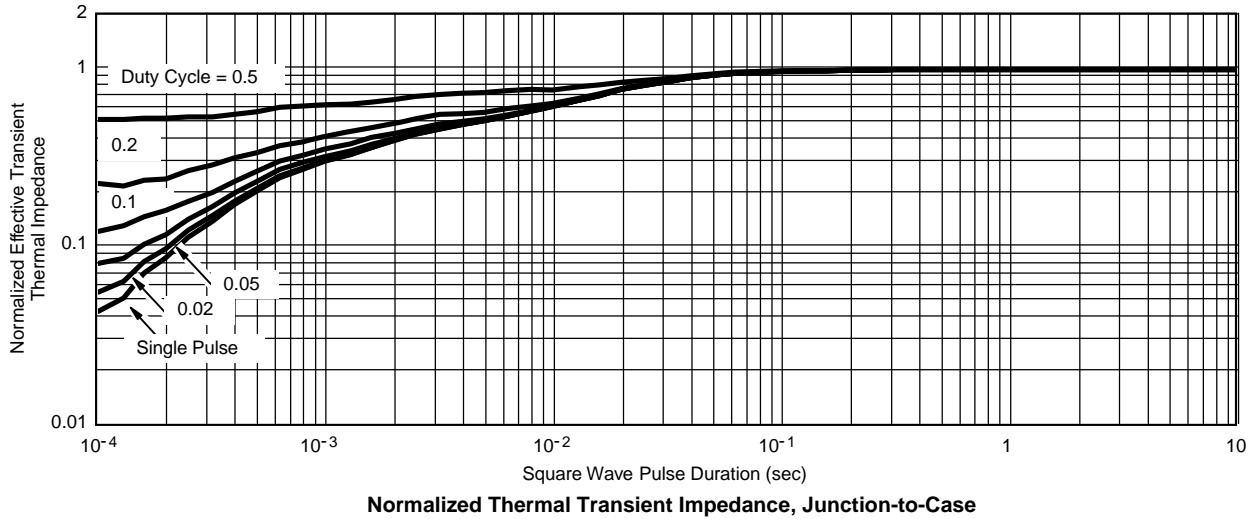


Safe Operating Area, Junction-to-Ambient

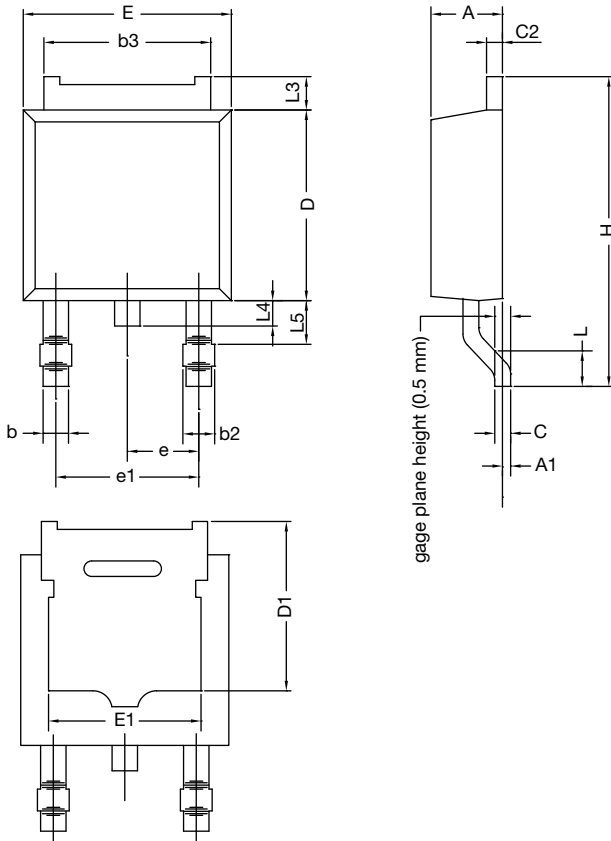
