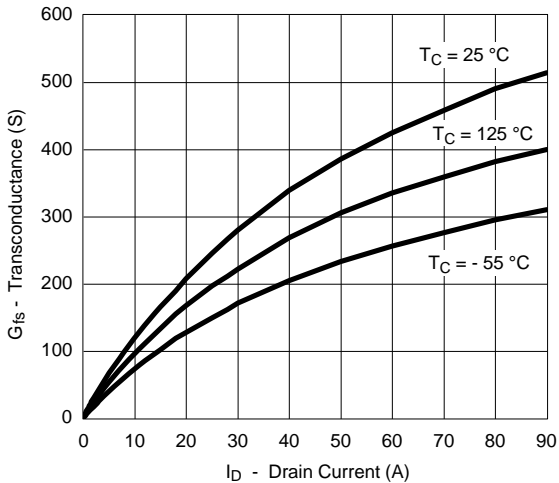

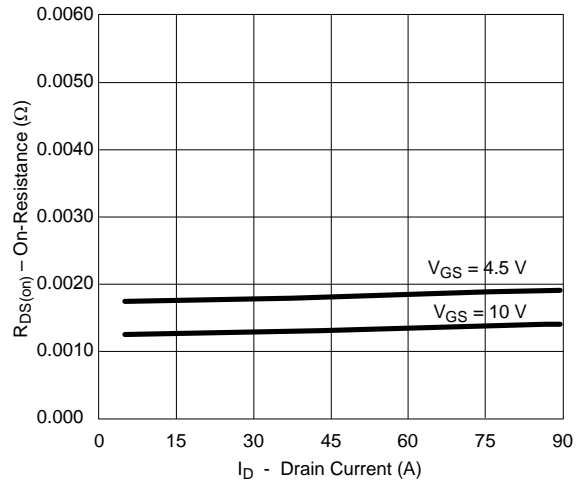

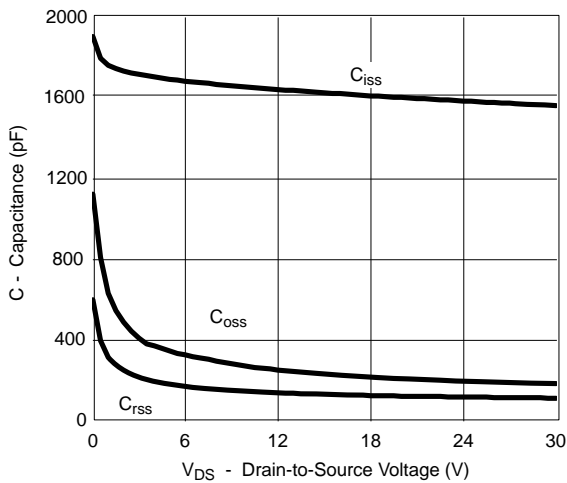

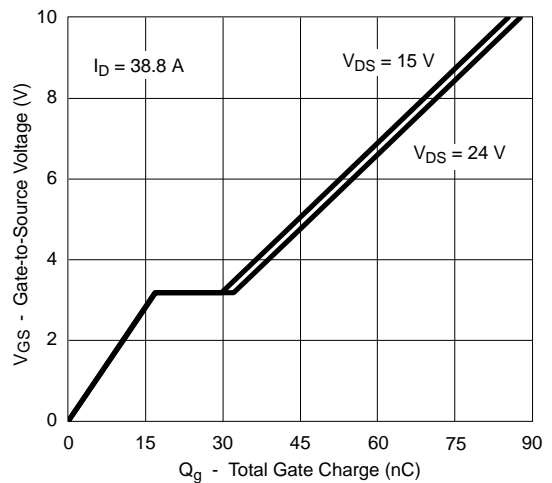
Transconductance

Gate Charge

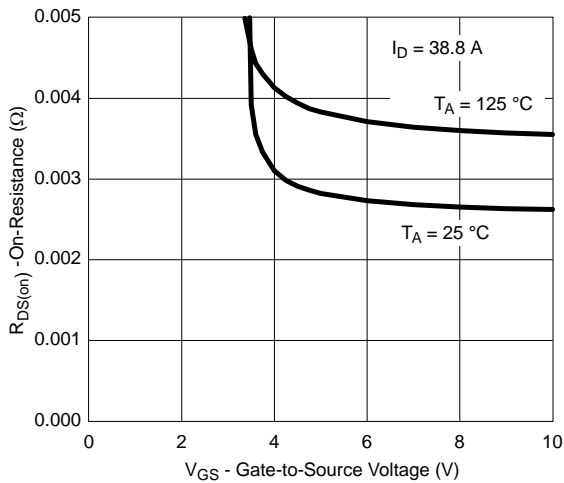

Threshold Voltage

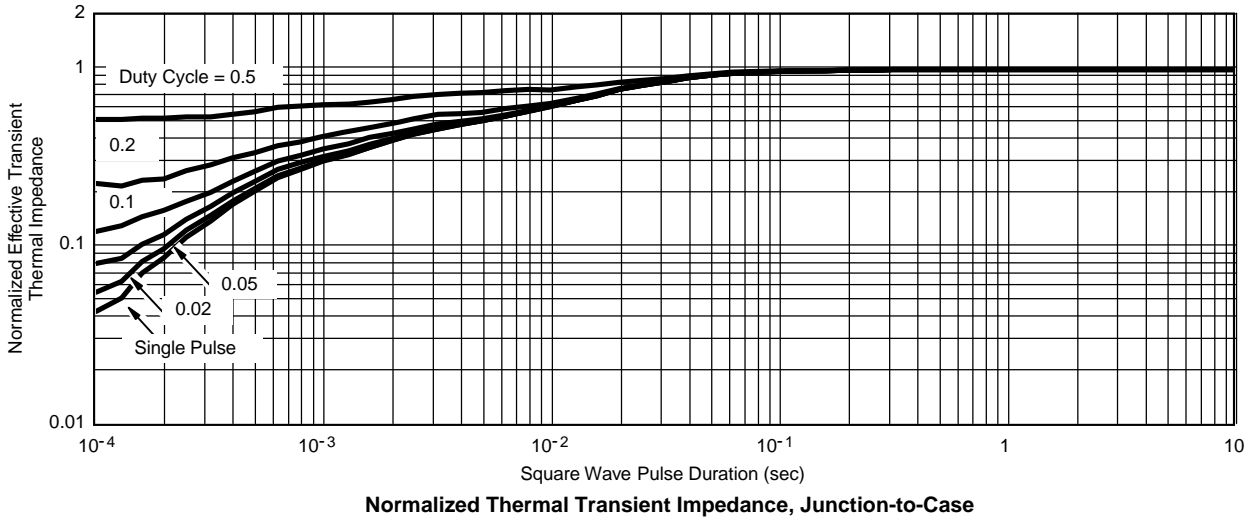

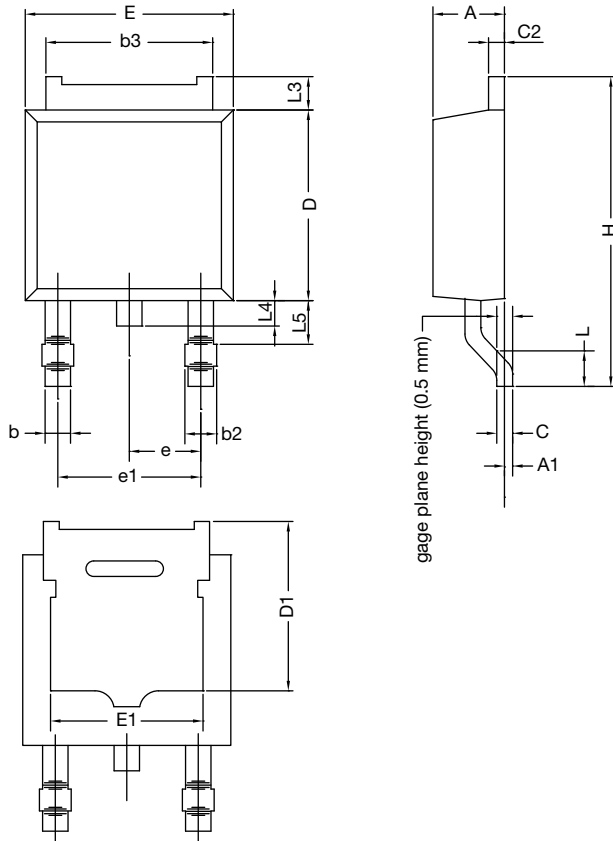
