



# TYPICAL CHARACTERISTICS (T<sub>A</sub> = 25 °C, unless otherwise noted)











#### On-Resistance vs. Junction Temperature

#### On-Resistance vs. Gate-to-Source Voltage




Drain Source Breakdown vs. Junction Temperature


Normalized Thermal Transient Impedance, Junction-to-Ambient

#### Normalized Thermal Transient Impedance, Junction-to-Case




