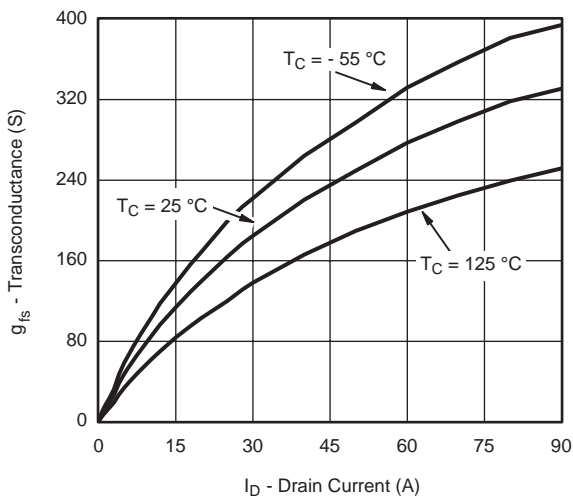

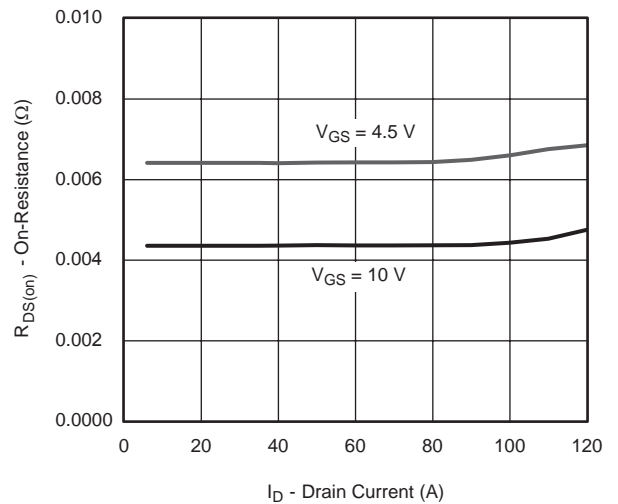

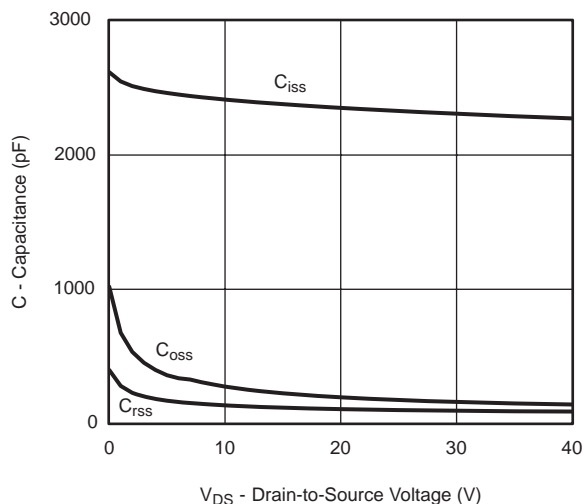

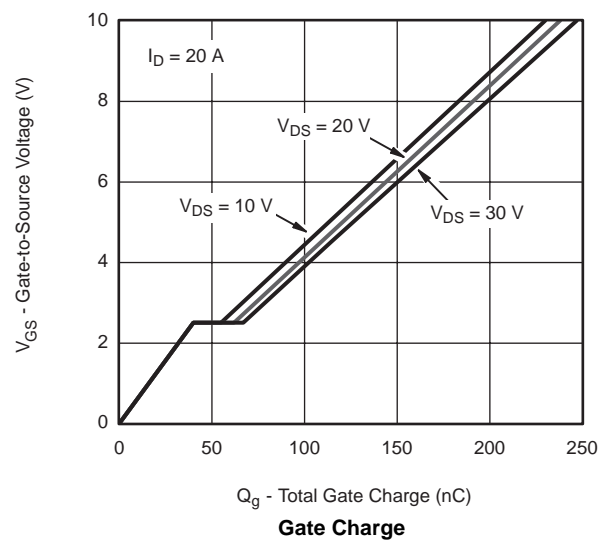
Transconductance

Capacitance

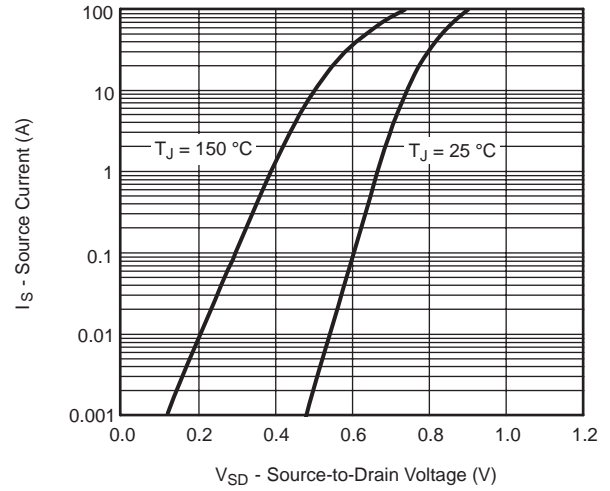

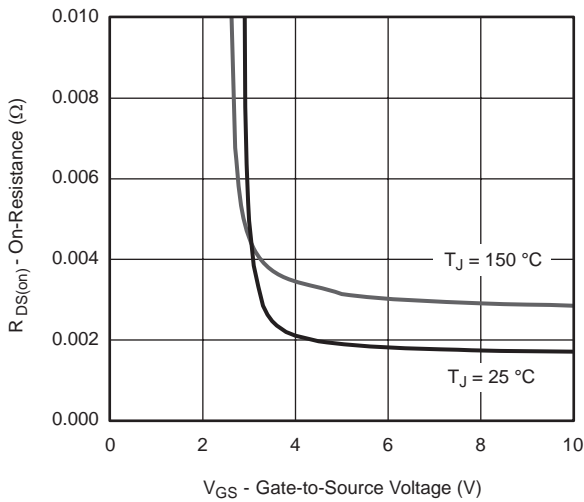

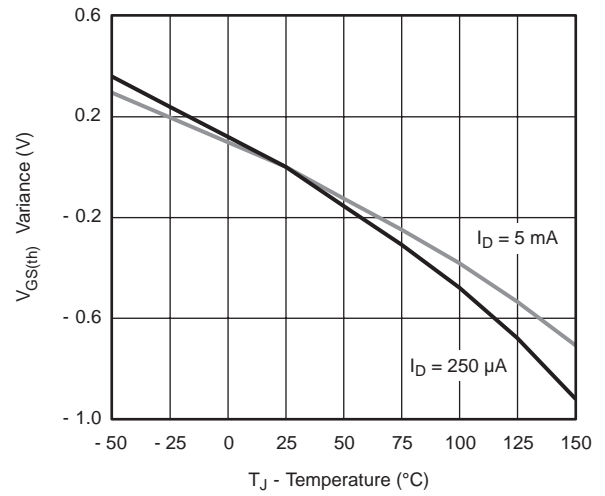
On-Resistance vs. Junction Temperature



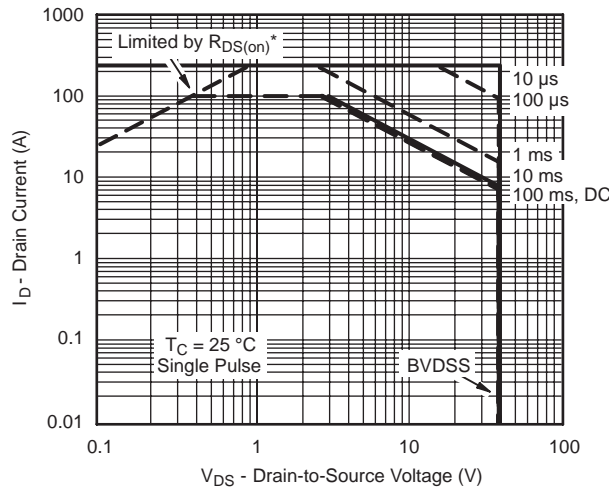
Forward Diode Voltage vs. Temperature

Threshold Voltage



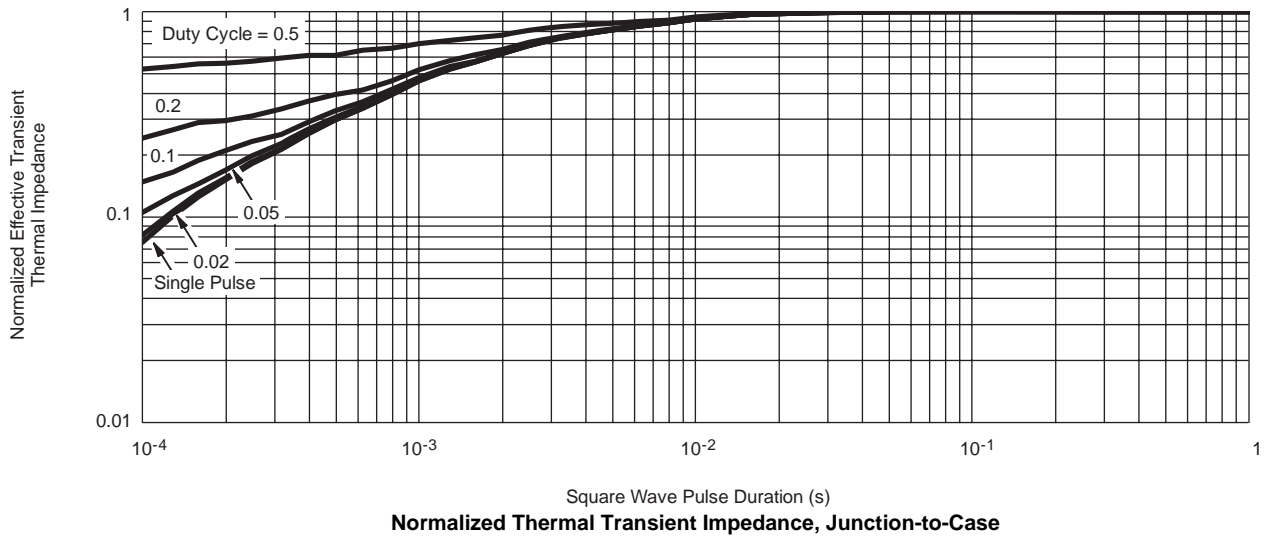

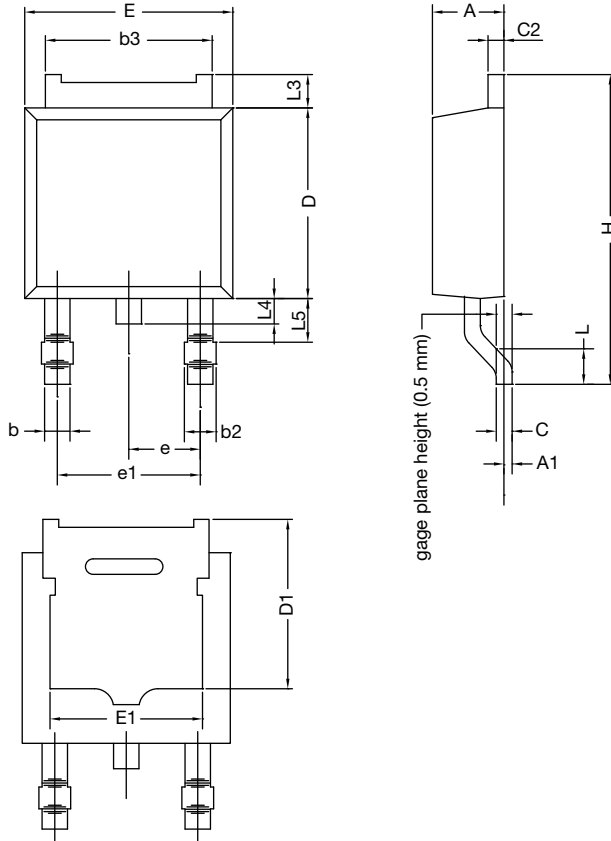

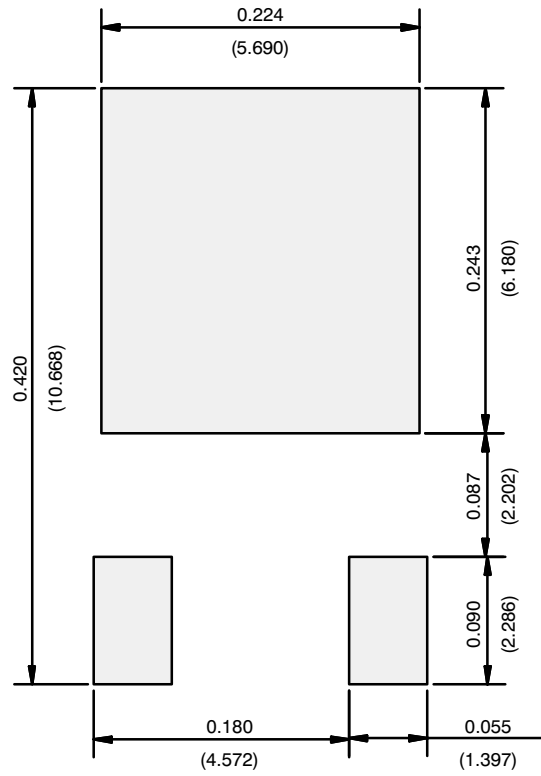
