












Threshold Voltage

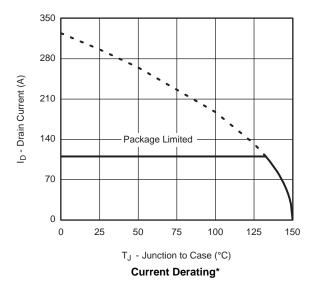





