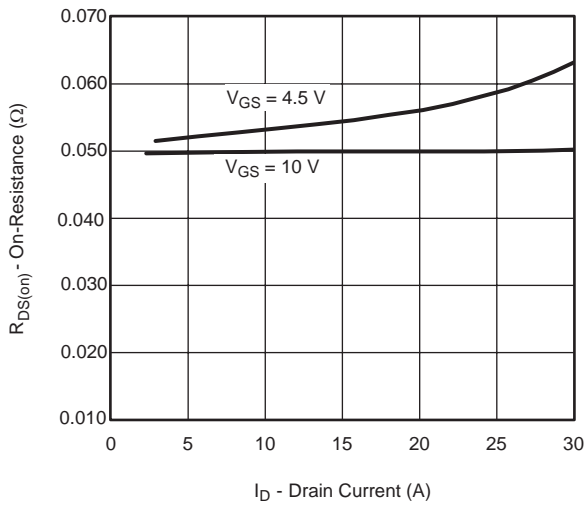

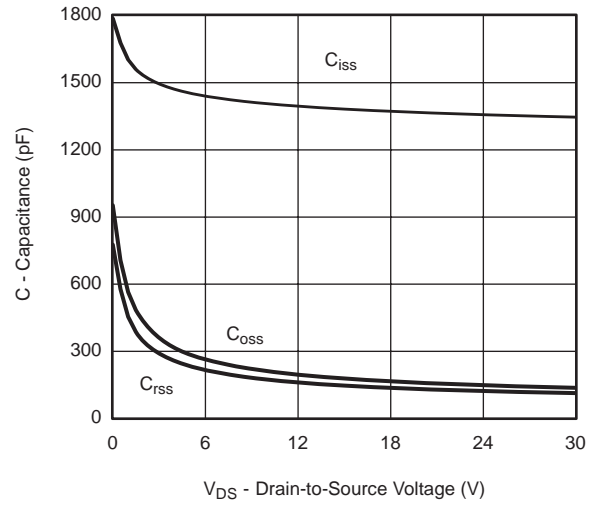

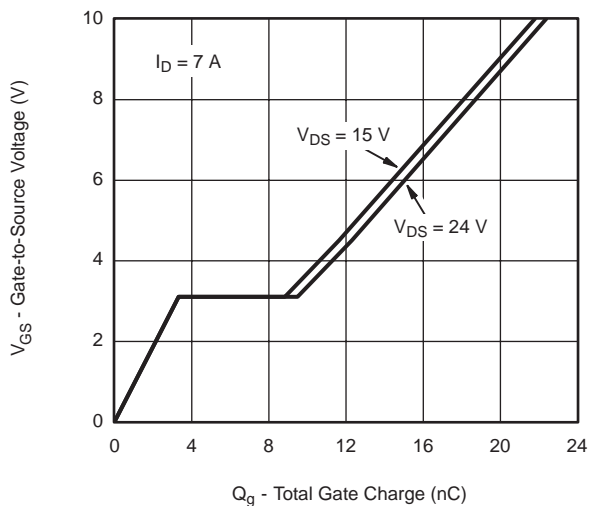
Transfer Characteristics



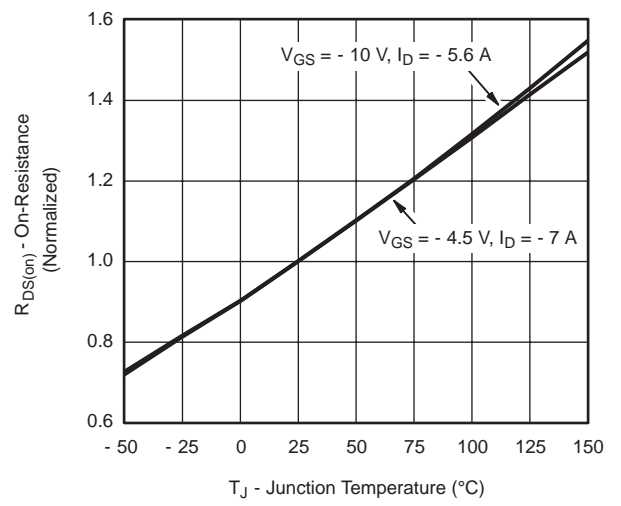
On-Resistance vs. Drain Current



Capacitance

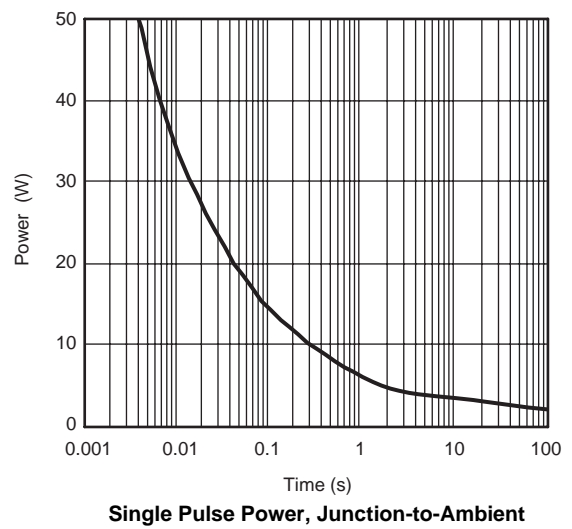


Gate Charge

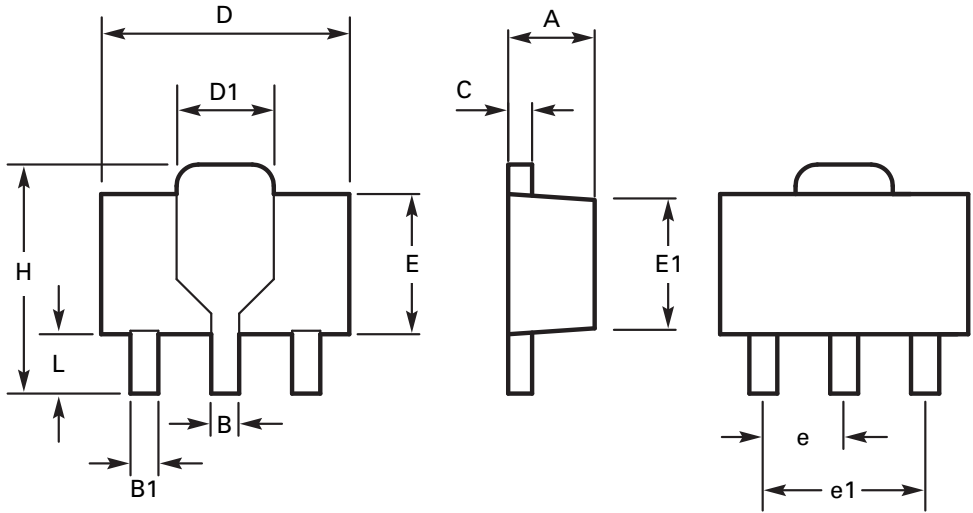


Normalized Thermal Transient Impedance, Junction-to-Ambient
