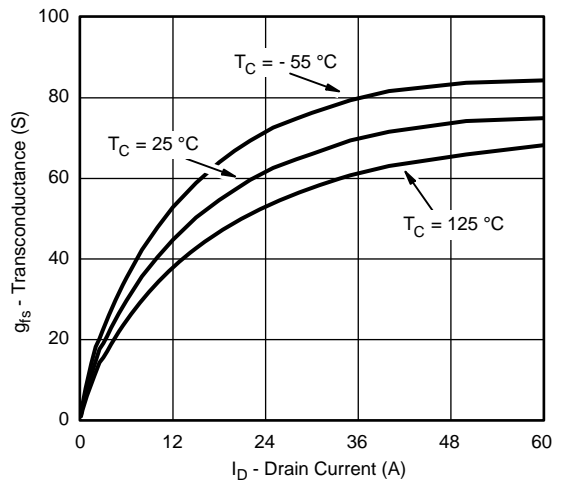

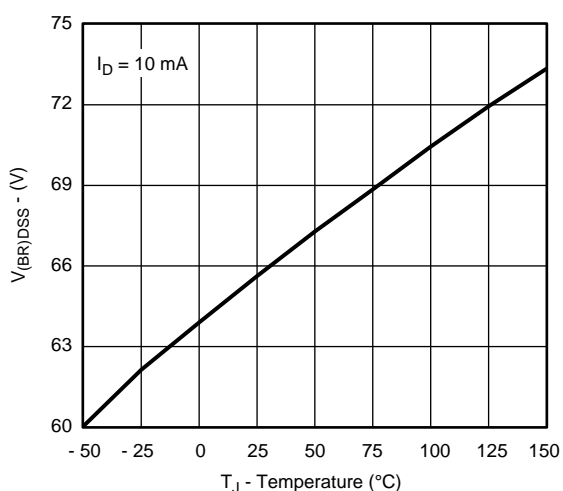
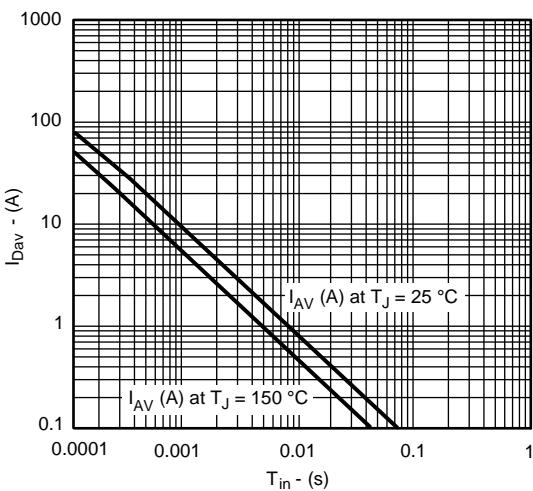
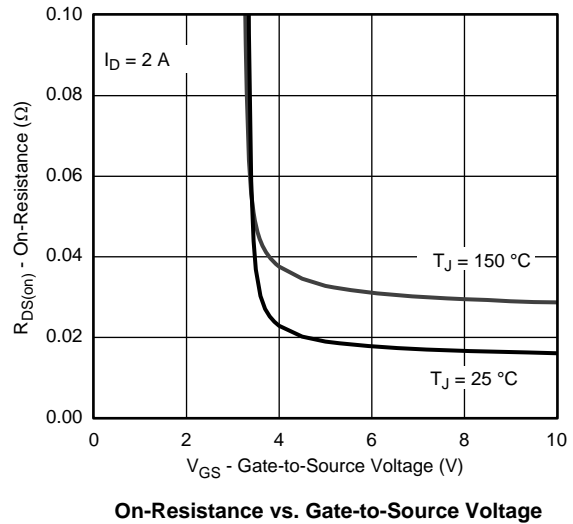
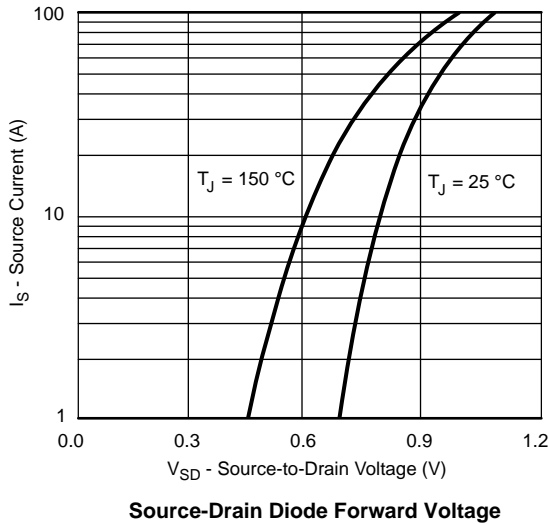
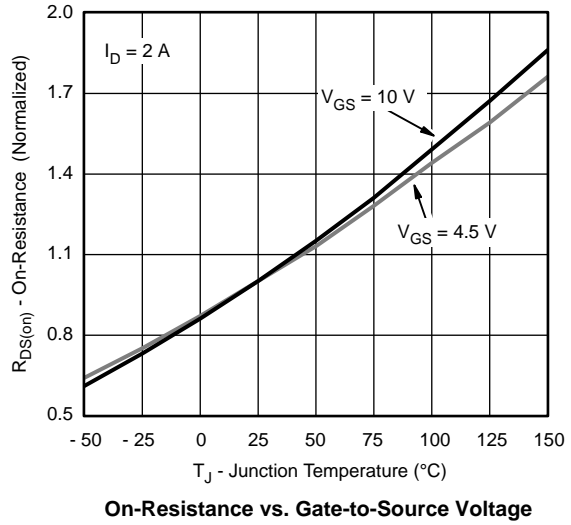
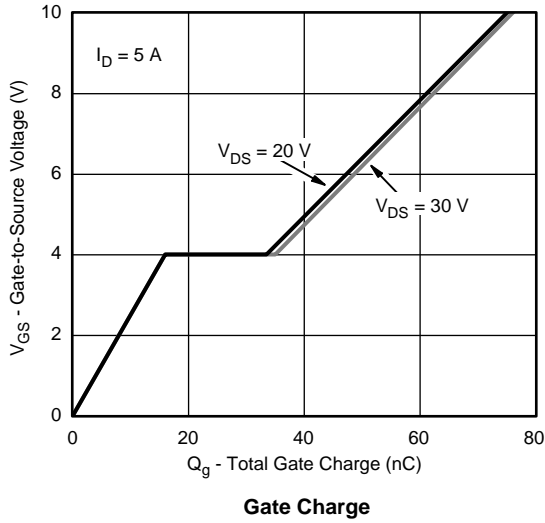


**On-Resistance vs. Drain Current**

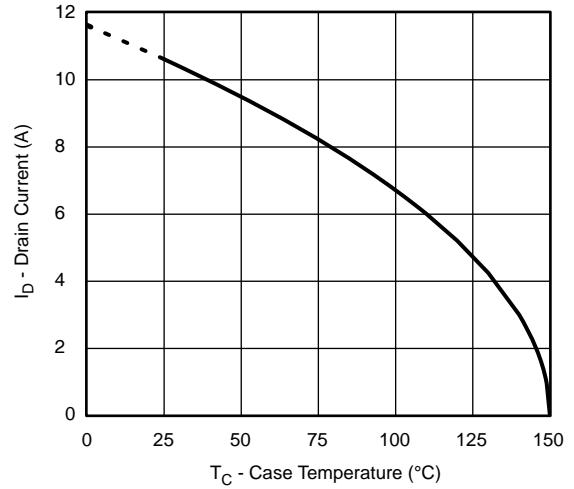

**Threshold Voltage**



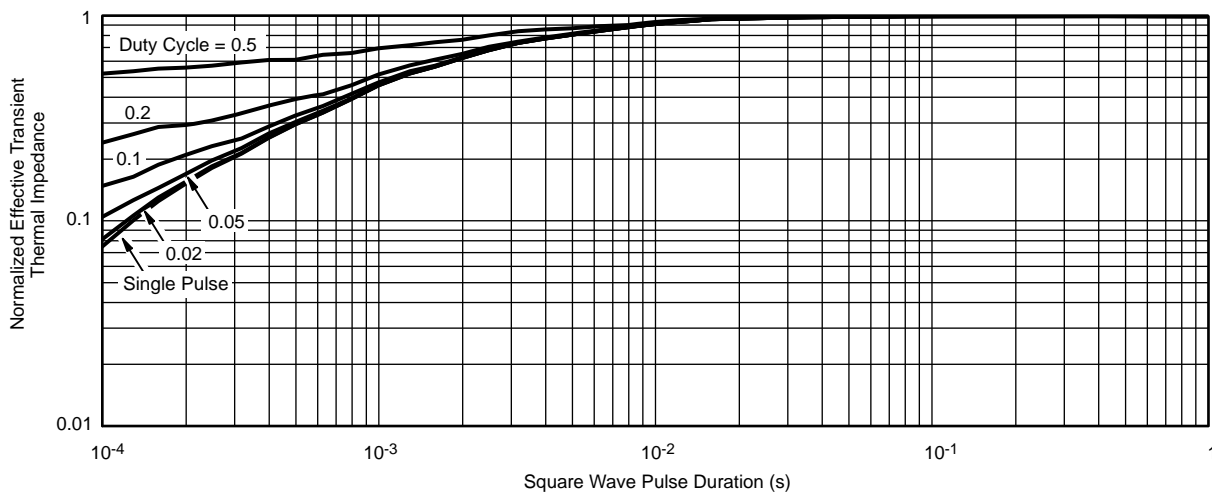
**Max. Drain Current vs. Case Temperature**



**Power Derating, Junction-to-Case**

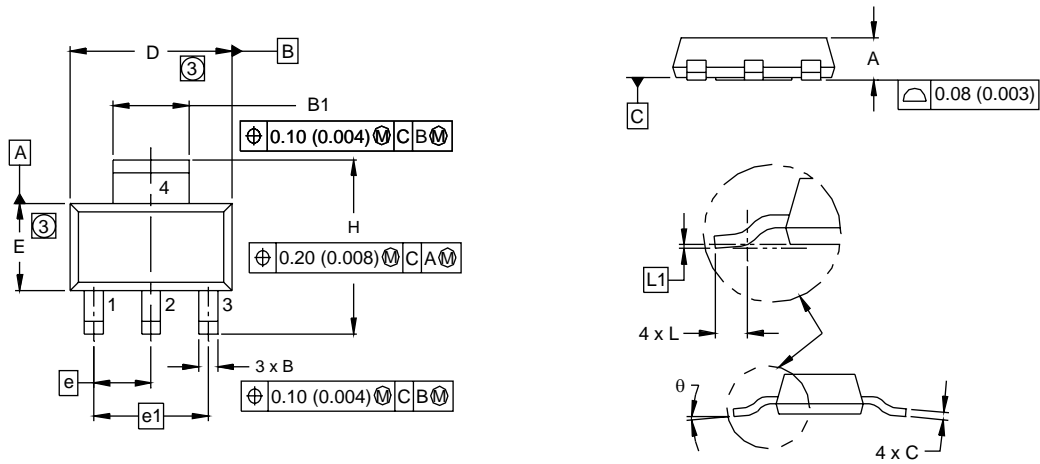


**Safe Operating Area, Junction-to-Case**
