# TMP1075EVM User's Guide

The industry standard LM75/TMP75 is now available with high accuracy and a wider temperature range. The TMP1075 is a drop-in replacement for the most prevalent digital temperature sensors with enhanced features. The TMP1075 provides up to  $\pm 0.5^{\circ}$ C typical accuracy over the  $-25^{\circ}$ C to  $+85^{\circ}$ C range, and  $\pm 1^{\circ}$ C typical accuracy over the  $-55^{\circ}$ C to  $\pm 125^{\circ}$ C range with 12-bit resolution, giving a temperature resolution of 0.0625°C. The Texas Instruments TMP1075EVM (Evaluation Module) provides the user a simple way to get started with TMP1075. The module and GUI are designed to provide the user a quick setup to evaluate the system and register map. The EVM features a perforation that allows the temperature sensor to be placed away from the MSP430 for remote temperature measurements and a header to connect multiple TMP1075's to the controller. This document provides detailed information about the hardware design and software installation.

# 1 Overview

The TMP1075EVM allows users to evaluate the performance of the best digital temperature sensor available in the VSSOP8 (MSOP8) package. The EVM comes in a USB stick form factor with an onboard MSP430F5528 microcontroller that interfaces with both the host computer and up to two TMP1075 devices using I2C interface. The module is designed to provide user flexibility separating the TMP1075 and MSP430 at the perforation location on the EVM board. The perforation allows the user to connect wires, cable, or header to both ends for remote temperature measurements or connects to desired system as well as connecting additional TMP1075s.

# **3 Board Connectors and Components**

The jumpers and connectors on the EVM, along with how to properly connect, set up, and use the TMP1075 Bench Board, are described here.

# 3.1 Input/Output Connector Description and Components

# 3.2 EVM Power Supply Input – J1

TMP1075EVM uses the +5-V input power supply of the USB connector to power the EVM. The EVM does not require an external power supply. The board is powered by the USB port and switches to +3.3 V. It can be powered by shorting the J1 jumper with a regulated voltage with desired programmable voltage such as 1.8 V, 3.3 V, and 3.6 V based on Equation 1. The EVM power supply input can be changed to any input power supply range of the TMP1075 1.7 V to 5.5 V; however, note that the MSP430 can only support a power supply range of 1.8 V to 3.6 V with the recommended V<sub>OH</sub> and V<sub>OL</sub> conditions listed in the TMP1075 data sheet specifications.

The resistor adjust  $R_{ADJ}$  can be calculated using Equation 1 with the desired voltage of  $V_{OUT}$  and where  $V_{REF} = 1.23 \text{ V}$ ,  $R_{ADJ} = R6$ , and  $R8 = 51.1 \text{k}\Omega$ .

$$V_{OUT} = V_{REF} + \left[ V_{REF} \times \left( \frac{R_{ADJ}}{51.1 \, k\Omega} \right) \right]$$

# 3.3 Interface Connector – J2

J2 is the USB connector, and used to connect the PC. The interface is used to access the device's registers and read the conversion data from the TMP1075 through I2C communication protocol.

### 3.4 Debug Jumper – J4

J4 is the connector that allows debugging the firmware using three wires instead of the standard 14-pin header. This connector is not populated.

### 3.5 Pushbutton Switch – SW1

Basically, the SW1 is to bring the MSP430 into a BSL mode for upgrading the firmware with combination of the USB connector manually referring to the picture in Figure 1 BSL button (SW1 switch). Press and hold the switch SW1 next to the USB connector while plugging the USB cable from the board to the PC. This will allow bringing the MSP430 into BSL mode.

# 3.6 Header Connector – J3

The purpose of the header connector is to isolate the heat source and prevent it from heat incoming directly into contact with the TMP1075, and the perforation allows users to snap at the breakout tab. When the TMP1075 is separated from the MSP430, it can be connected through wires or header to both ends for remote temperature measurements.

# 3.7 LED – (D4, D6, D7)

There are a total of three LEDs on the board: green (D4), red (D6), and orange (D7). The green LED is the power supply indicator, and it should be turned ON. The orange LED should not blink when the EVM is initially plugged into the PC. The orange LED will blink if the power-on-reset (POR) tests on the MSP430 microcontroller fails on start-up or if the Test LED button is toggled. It will blink when the Start Graph button is pressed. The red LED is the Alert pin indicator when the Alert pin is pulling LOW.



# 3.8 I2C Slave Addresses – (R15, R16)

TMP1075 is capable of supporting up to 32 I2C 7-bit addresses. The TMP1075 is connected to the bus by a unique slave address to operate data transfer from the master-transmitter to the slave-receiver or the slave-transmitter to the master-receiver. The TMP1075 can be configured desired two serial bus addresses depending on the state of the A0, A1, and A2 as Table 3. The EVM can be configured up to two addresses. At default, the resistor R16 is soldered, and configured for 0x48h address. For more details information, refer to the Address Pins and Slave Addresses for the TMP1075 table in the TMP1075 Temp Sensor With I2C and SMBus Interface in Industry Standard LM75 data sheet (SBOS854).

# 4 System Setup

The TMP1075EVM hardware consists of the USB2ANY Platform and the TMP1075EVM altogether in one single board. The unit is easily connected through USB connector into the computer as shown in Figure 3.

# 5 Software Installation

### 5.1 Graphical User Interface (GUI)

The EVM software is tested on the Microsoft Windows 7 and 10 operating system (OS). The software also functions on other Windows operating systems. The EVM software is available through the EVM product folder on the TI website. To download the software to your system, simply follows the instructions below.

- 1. Go to the TMP1075EVM web page on the TI website: http://www.ti.com/tool/TMP1075EVM. Scroll down to the *Software* section and download the latest evaluation software.
- Unzip the downloaded file into a known directory. Once the files are extracted, navigate and run the Setup\_TMP1075EVM\_GUI.exe file located in [Unzip location]. The EVM software installer then begins the installation process as shown in Figure 4.

3. Follow the on-screen instructions by clicking the *Next* button to install the software. The following this option, two license agreements are presented as shown in Figure 5 and Figure 6 that must be accepted. After accepting both the Texas Instruments and National Instruments license agreements, the user is given the choice of selecting the directory to install the program; usually, TI recommends choosing the default setting stored in the *C:\Program Files (x86)\Texas Instruments\TMP1075EVM* path as shown in Figure 7.

4. Some servers must configure the proxy before authorizing users gains access outside of the internal network, and they act like an intermediary between the user's computer and the internet. 5. For first-time installation, ensure the LabVIEW Run Time Engine is listed in the following summary as shown in Figure 9. TMP1075EVM GUI is required LabVIEW 2016 f5 runtime engine for proper operation. Once the Next button is clicked, the progress bar opens and shows the installation of the software. It may take some time to download the LabVIEW Run Time Engine on the first installation. Users may be prompted to download the file when installing the software for the first time, especially if the LabVIEW Run Time Engine checkbox is checked.

Upgrading the Firmware

### 6 Upgrading the Firmware

There are two ways to upgrade or program the firmware of the TMP1075EVM board. The first method is to click on the *Upgrade Firmware* through the TMP1075 GUI or go directly to the directory of the TMP1075EVM folder.

# CAUTION

TMP1075EVM software must be installed before performing any tasks.

In Figure 12, the Upgrade Firmware button will call the MSP430 USB Firmware Upgrade Example application in the TMP1075EVM folder C:\Program Files (x86)\Texas Instruments\TMP1075EVM\MSP430 USB Firmware Upgrade\BSL\_USB\_GUI.exe. So, another method is to go directly to the folder instead of running from the GUI. For programming multiple EVMs, the second method is the best option.

- An error window will appear if the computer cannot communicate with the EVM. This is due to the driver not recognized by the computer yet because the firmware is not programmed. On top right of the GUI, ensure the *Demo Mode* checkbox is checked.
- Click on Update Firmware button. This will launch the MSP430 USB Firmware Upgrade Example program.
- The confirmation pop-up dialog appears in Figure 13. Click on *OK* button to precede the firmware update.

To update the firmware of the TMP1075EVM, please following the procedure below.

- 1. Start the *MSP430 USB Firmware Upgrade Example* program as shown in Figure 15, and click on *Next* to proceed the update and accept the license agreement. Note that in Figure 16, it shows *No device connected* at this time.
- 2. Before starting the upgrade, the BSL mode must be invoked by disconnecting the TMP1075EVM from the USB cable.
- 3. Press and hold the SW1 switch button down while connecting the USB cable.
- 4. Once the BSL mode is now invoked, the *MSP430 USB Firmware Upgrade Example* shows *Found 1 device* in Figure 17.
- 5. Select the Select Firmware radio button and click on Browse button to navigate the firmware file in this folder C:\Program Files (x86)\Texas Instruments\TMP1075EVM\Firmware. The firmware file name is USB2ANY\_F5528.txt version v2.7.16.
- 6. The firmware image is programmed, and the TMP1075EVM restarts automatically. The new firmware is now ready to use as shown in Figure 18.

# 7 TMP1075EVM Setup and Operation

### CAUTION

Do not exceed the power supply rating of the MSP430.

### 7.1 Launching and Running the Software

The TMP1075EVM is recognized by the host as a generic human interface device (HID); therefore, there is no required proprietary driver to install on the user's PC. It shows the typical response to connecting the USB-to-I2C converter board to a PC USB port for the first time. Typically, the computer responds with a Found New Hardware: USB device pop-up dialog. The pop-up window then typically changes to Found New Hardware: USB Human Interface Device. This pop-up indicates that the device is ready to be used. The USB-to-I2C Converter uses the human interface device drivers that are part of the Microsoft Windows® operating system.

The TMP1075EVM GUI can be run from the Start Menu or from Windows desktop. It is located in a folder Start -> Programs -> Texas Instruments -> TMP1075EVM -> TMP1075EVM.exe. Clicking the OK button will take the user to the main window of the GUI.

- 1. Connect the TMP1075EVM to a USB port on a PC as shown in Figure 20.
- Launch the TMP1075EVM software by clicking on Start >> All Program >> Texas Instruments >> TMP1075 EVM >> TMP1075EVM.exe. The TMP1075 EVM GUI should automatically initialize and connect to the HID port. A successful connection will show HARDWARE CONNECTED highlighted in green color on the bottom of the GUI status indicator. If there is a connection problem please verify if the TMP1075EVM has an established connection with the PC. A fail connection if the status indicator shows as DEMO MODE.

# 7.2 Tab Pages Selection

The tab pages selection consists of three tabs: Main (Temperature Graph), EVM Set-Up, and TMP1075 Configuration. Launching the software will take you to the main window GUI (Main tab) display. By clicking on the page tab allows switching between pages of the tab control.

# 7.3 Main Tab

The *Main* tab provides graphing the temperature result as well as other features:

**Clear Chart** erases the contents of the Temperature Chart box or click right button of the mouse on the display screen then select *Clear chart*.

**Save Chart** prompts for a file name, and then saves the contents of the current Temperature graph box to \*.csv file. Note that the **Clear Chart** button must be performed first before log the data; otherwise, it will also save from the previous data in the memory.

Current Value shows the current temperature of the TMP1075.

Celsius or Fahrenheit is to toggle the temperature conversion Celsius to Fahrenheit.

**One Shot** is available on the Temperature Chart tab. The One Shot button writes to the TMP1075 configuration register with the one-shot in conversion mode. This setting initiates a temperature conversion within the TMP1075 device that updates the temperature result registers. After the one-shot conversion finishes, the device goes into shutdown until the next trigger of one-shot again.

**Continuous** performs the temperature conversion continuously when the shutdown mode bits is configured in the configuration register to continuously. Each temperature conversion consists of an active conversion period followed by a standby period based on the time of the conversion cycle configuration.

Alert high and low limit register can be set by entering the value in °C or °F based on °C/°F control on Main tab that stores the high and low limit for comparison with the temperature result.



# 7.4 Register Tab

The *Registers* tab provides access to the registers of the TMP1075, performing read and writes commands. Changes to the configuration page are mirrored here, and vice versa. For more details about each register, refer to the latest TMP1075 (SBOS854) data sheet.

**Firmware** is allowed to check the firmware revision on the MSP430F5528 microcontroller by clicking the *Read* button or *Update The Firmware Revision*.

I2C Configuration is to change the bus frequency and slave address.

**Software Reset** performs software reset on the TMP1075 device by issuing a general call. After software reset, the values displayed in the EVM software may be out of sync with the device register contents. To sync register contents after software reset, click Read All in the Registers tab page.

**Demo Mode** allows to operate the GUI without a hardware connected. In this mode, the handle is closed. Clicking on any buttons or drop-down menu will be automatically closed the software GUI.
