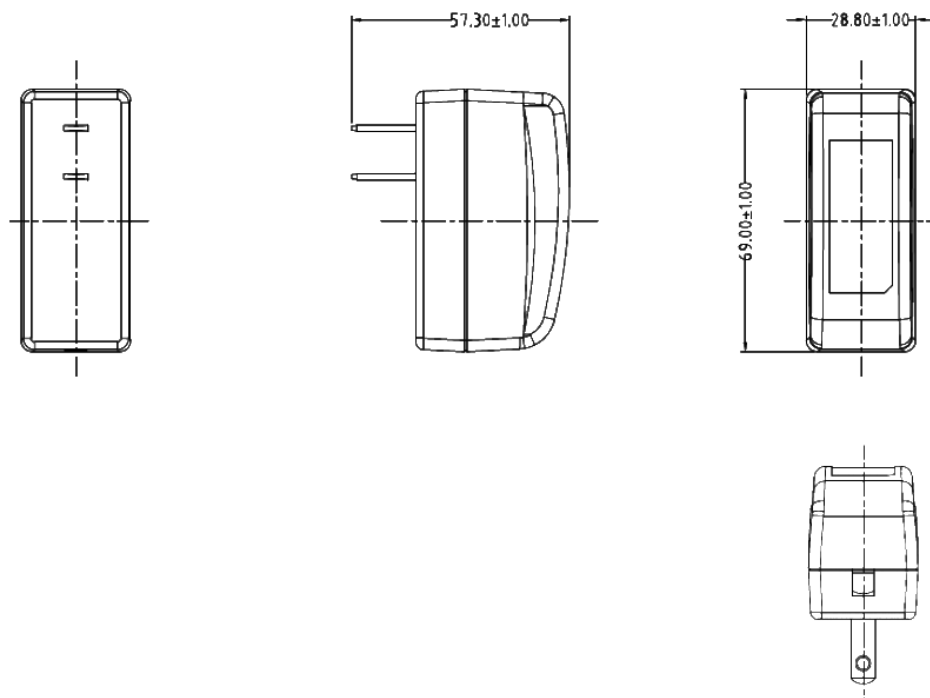

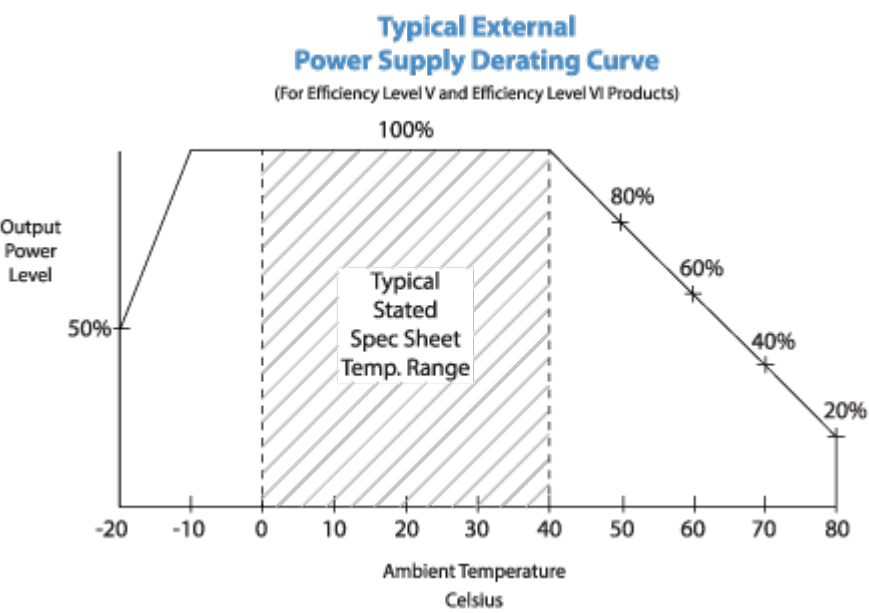

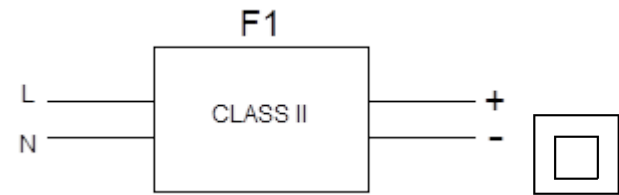
DERATING CURVE
