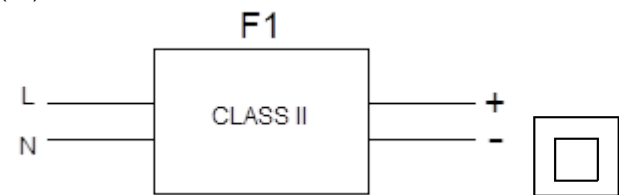
DERATING CURVE
