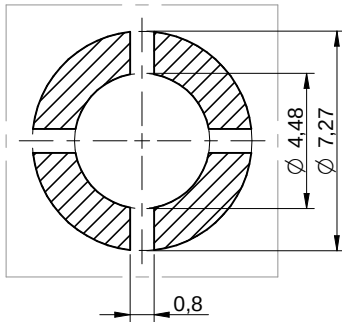
sectional drawing A-A

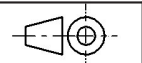
### Packaging:

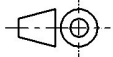
