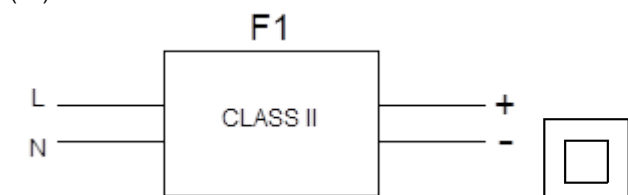
DERATING CURVE
