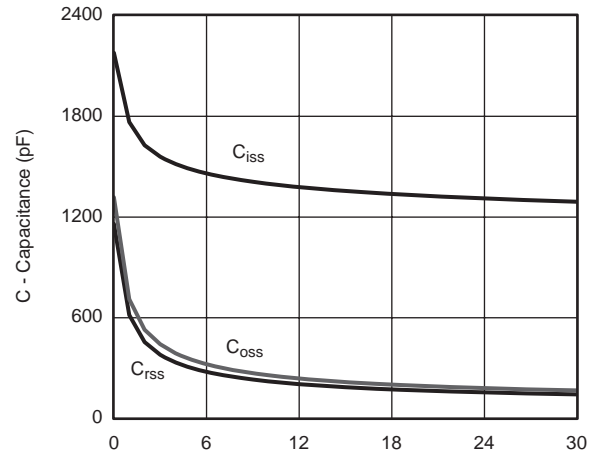
$V_{DS}$  - Drain-to-Source Voltage (V)

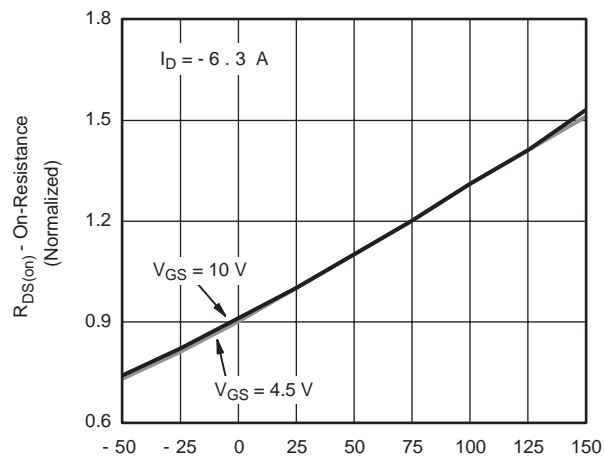
$I_D$  - Drain Current (A)

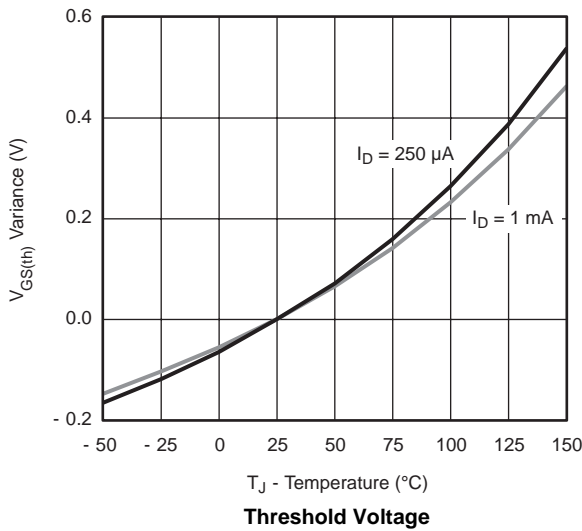
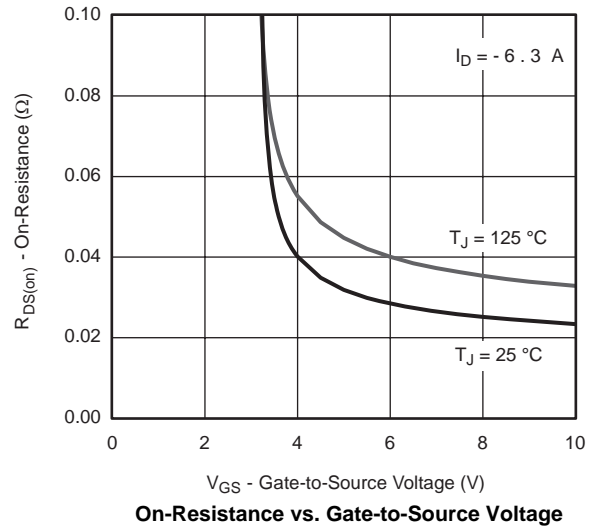

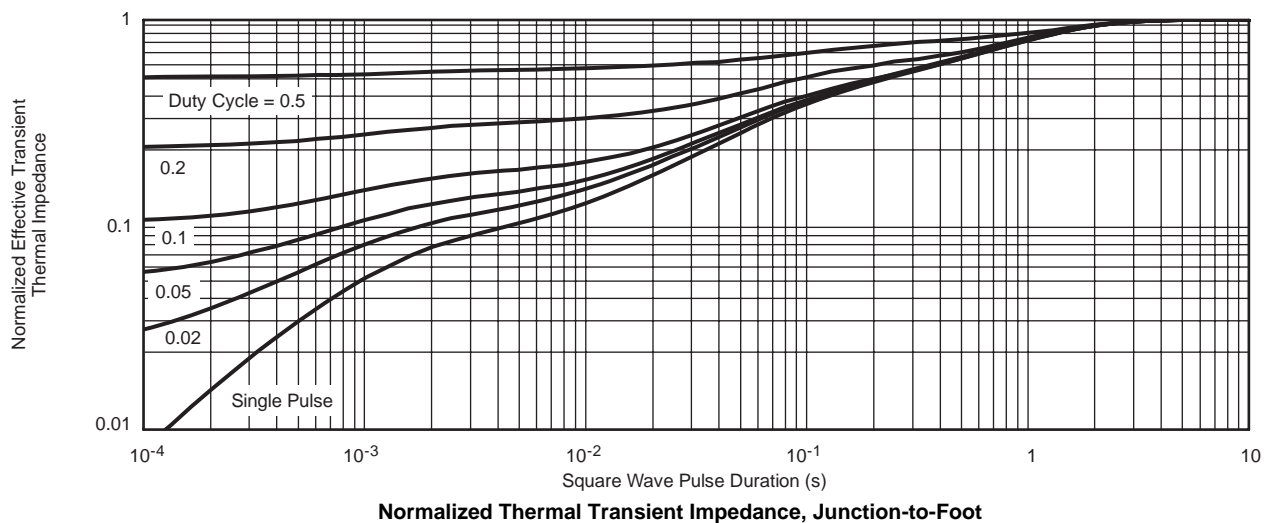
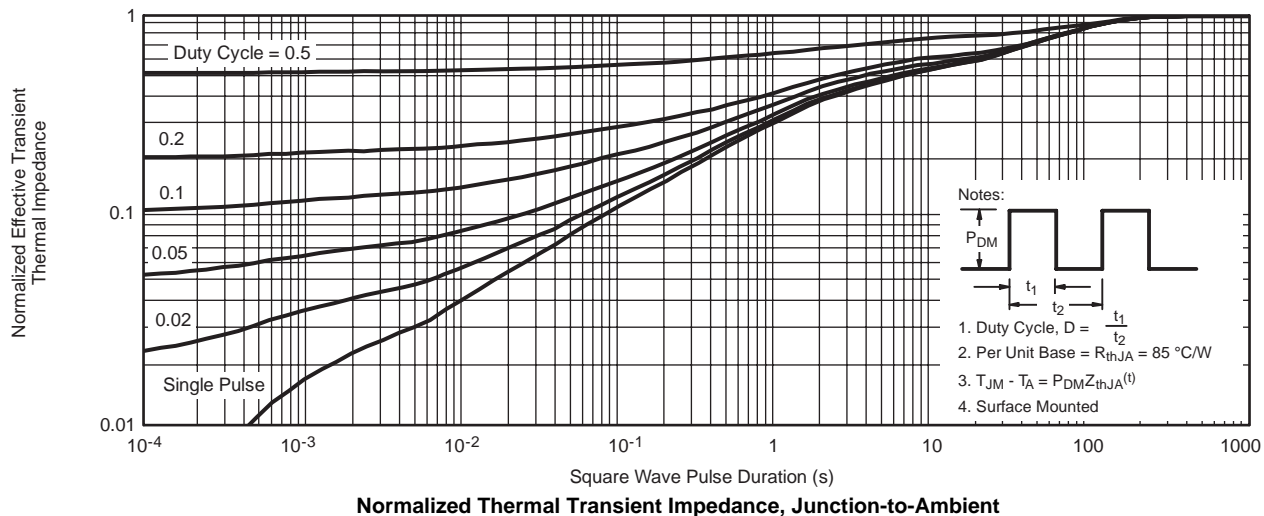
**Power, Junction-to-Foot**
