




Source-Drain Diode Forward Voltage

On-Resistance vs. Gate-to-Source Voltage






Single Pulse Power, Junction-to-Ambient



 * V_{GS} > minimum V_{GS} at which $R_{DS(on)}$ is specified






Normalized Thermal Transient Impedance, Junction-to-Ambient
