









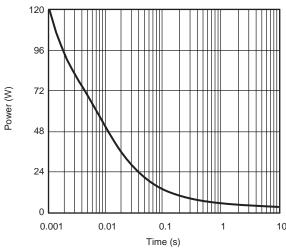
Source-Drain Diode Forward Voltage



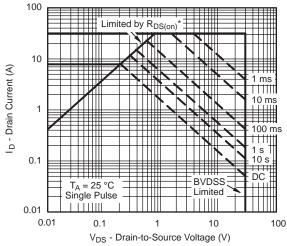
T_J - Temperature (°C) **Threshold Voltage**



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power (Junction-to-Ambient)






Normalized Thermal Transient Impedance, Junction-to-Ambient
