









Source-Drain Diode Forward Voltage




Safe Operating Area

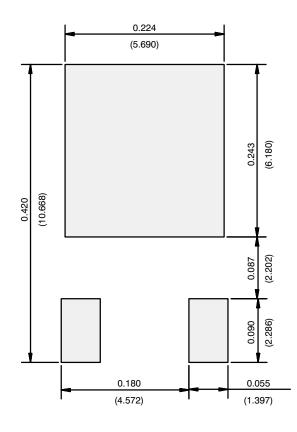
