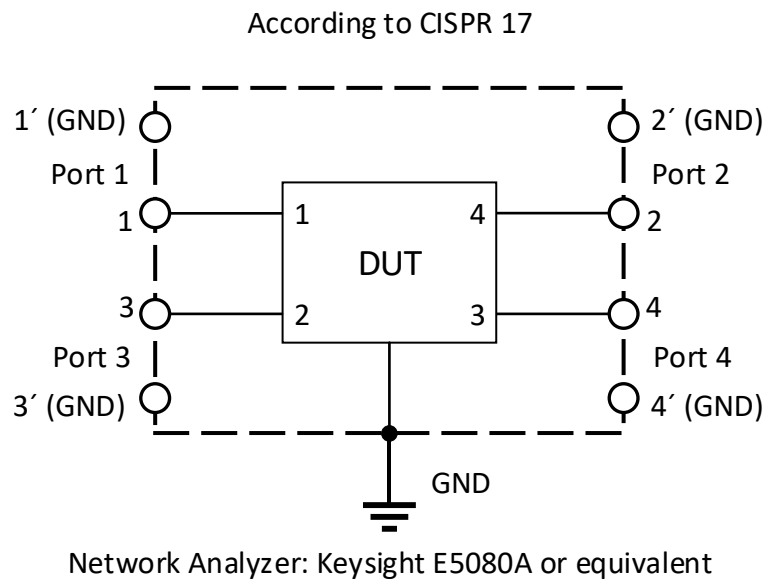


Typical Impedance Characteristics:

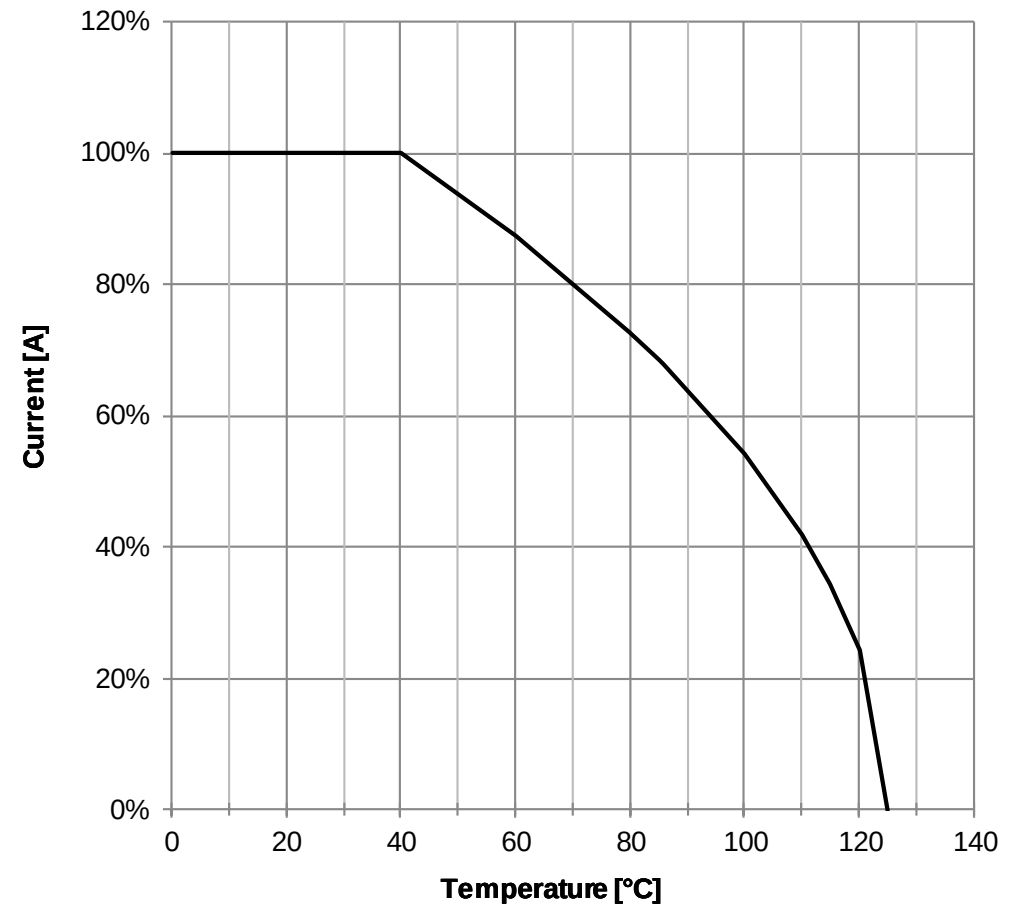

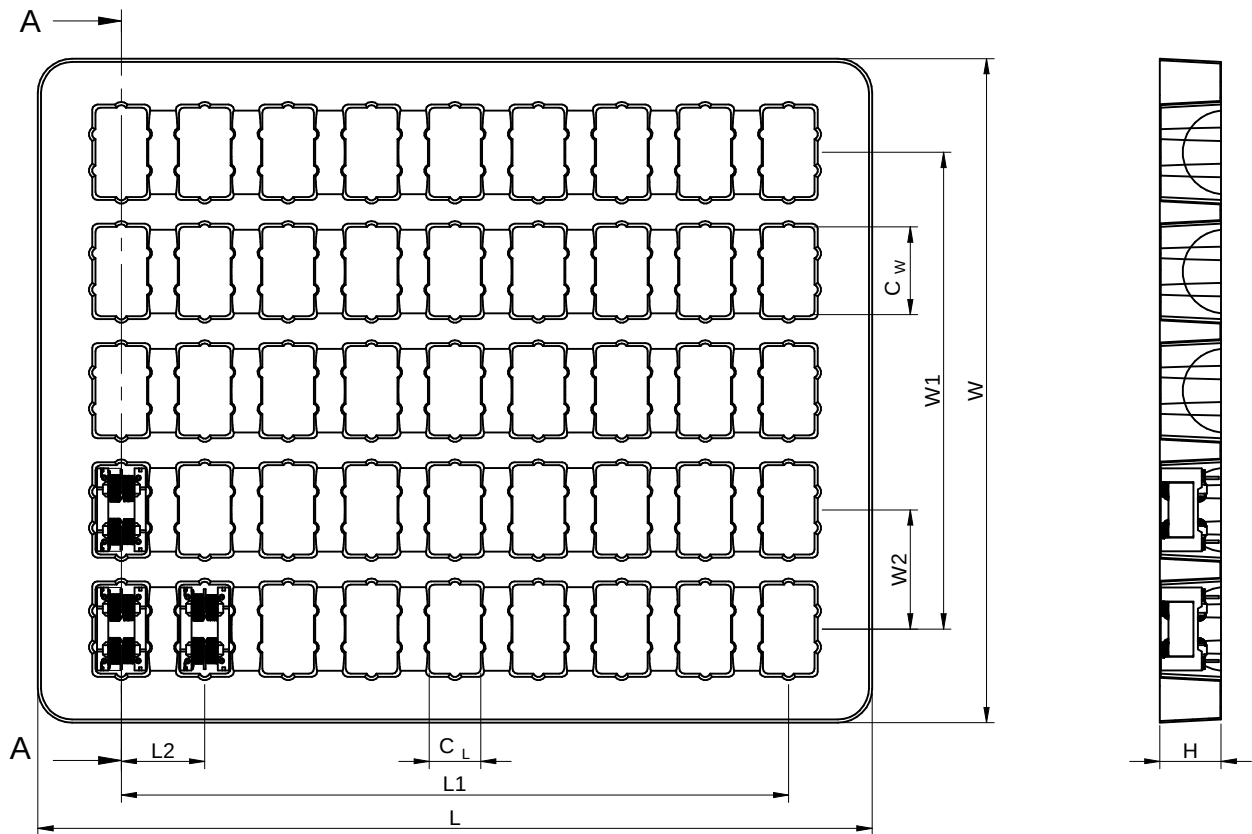


Derating Curve:



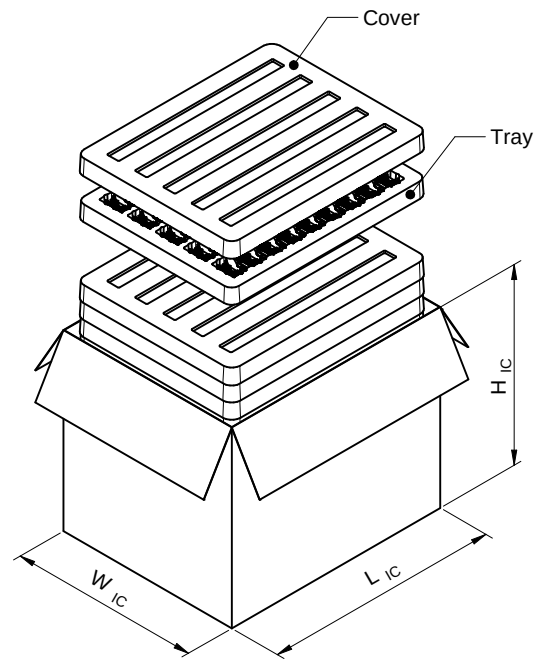

Soldering:

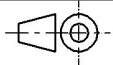

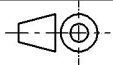
