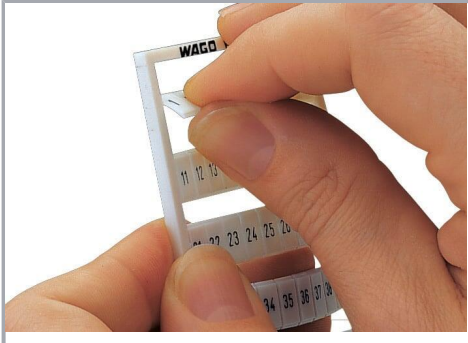

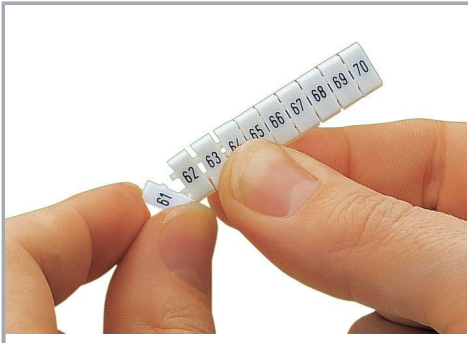

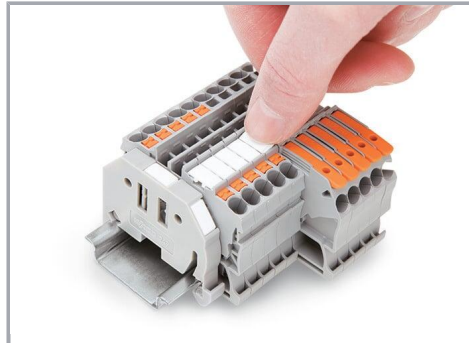
Separating a strip from the WMB or WMB marker card.



Stretching a WMB marker strip.

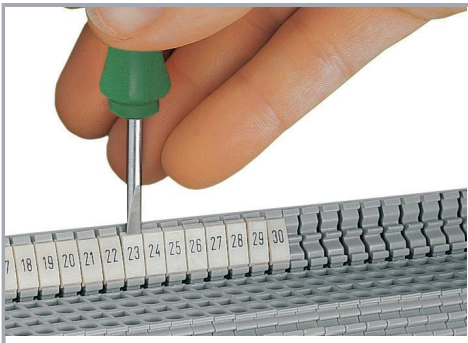


Separating an individual marker from the WMB marker strip – for larger terminal blocks.

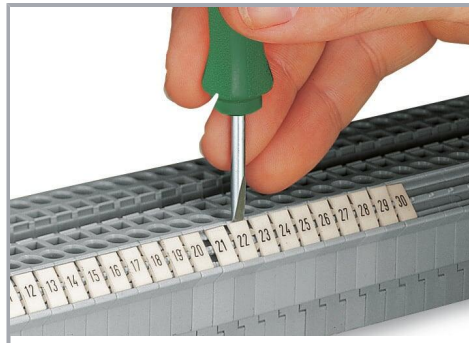


Snapping a marking strip into the marker slot.
