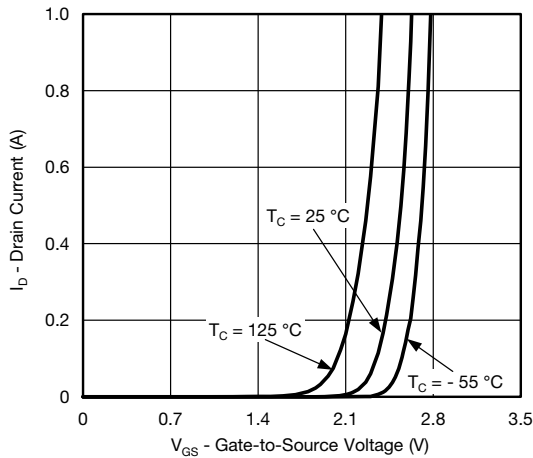

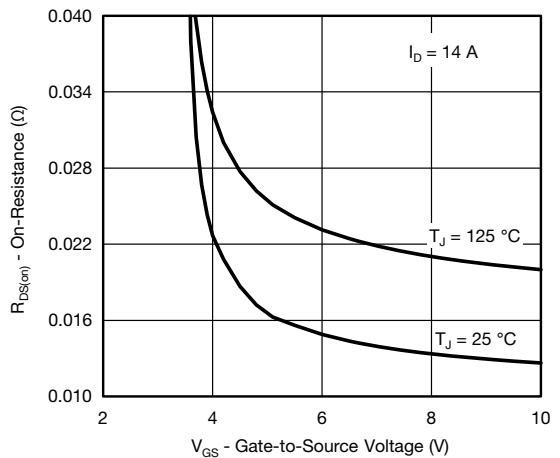

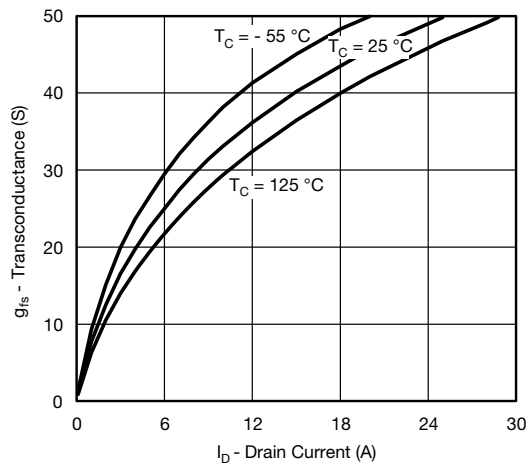
**On-Resistance vs. Drain Current**



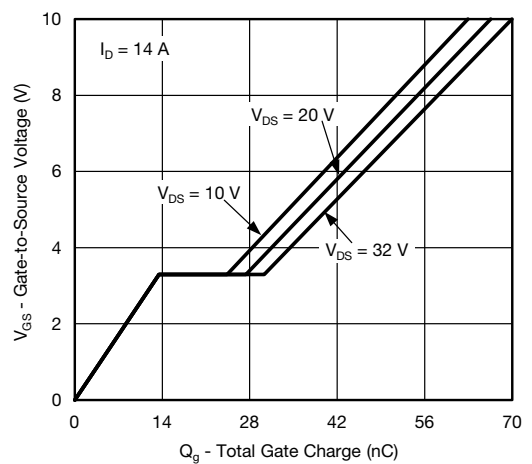

**On-Resistance vs. Gate-to-Source Voltage**

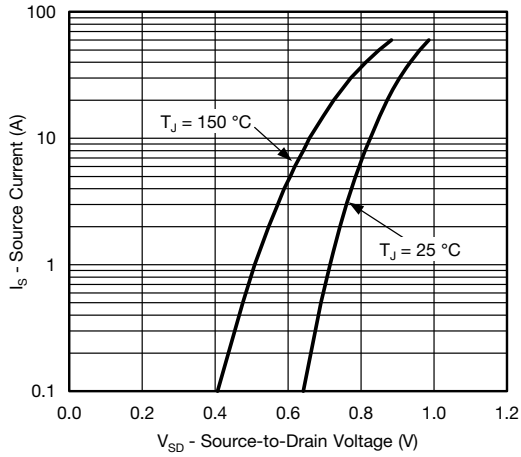

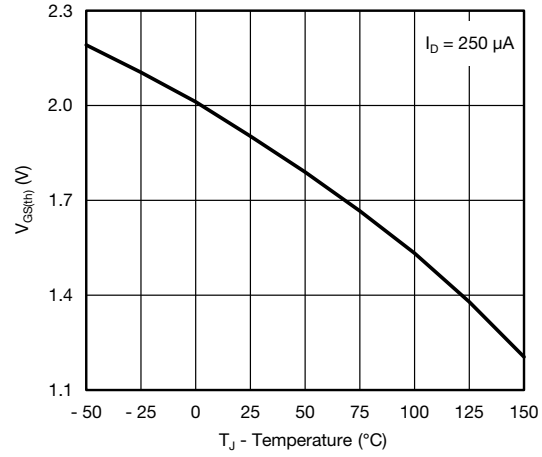

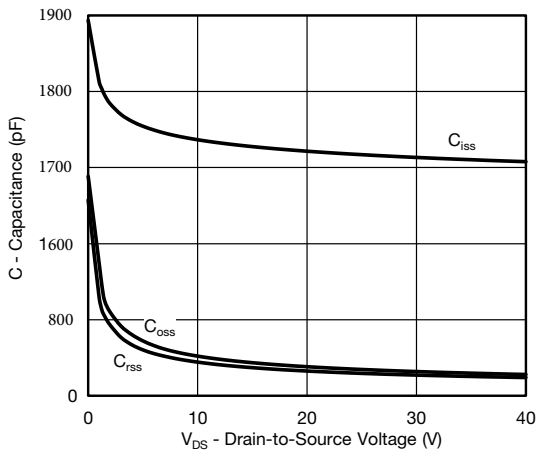

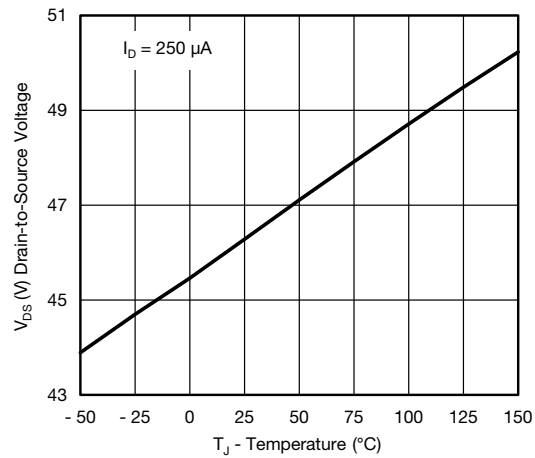

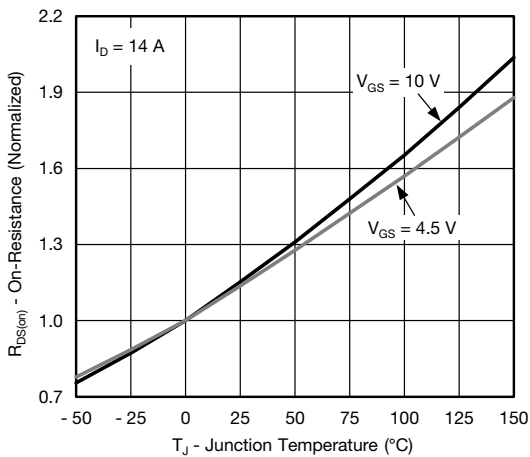

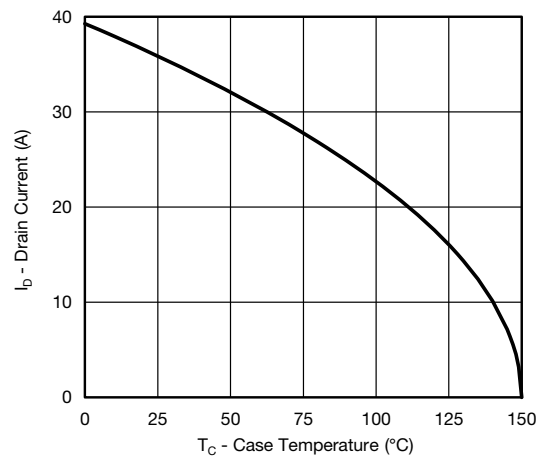

**Drain Source Breakdown vs. Junction Temperature**

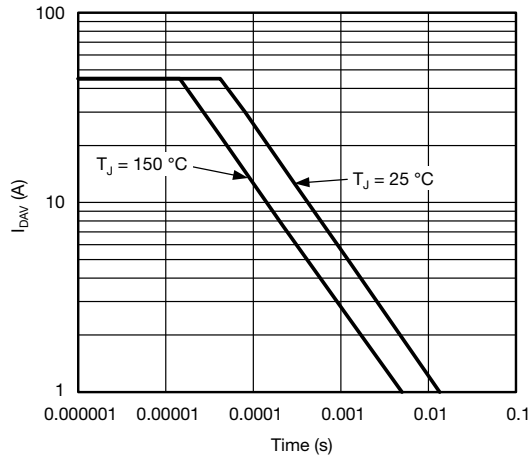

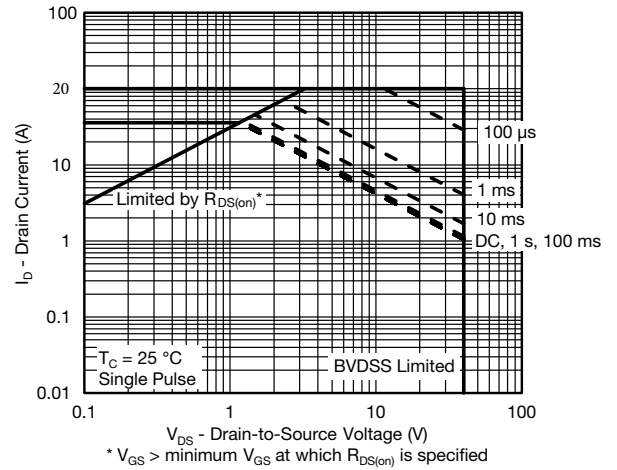

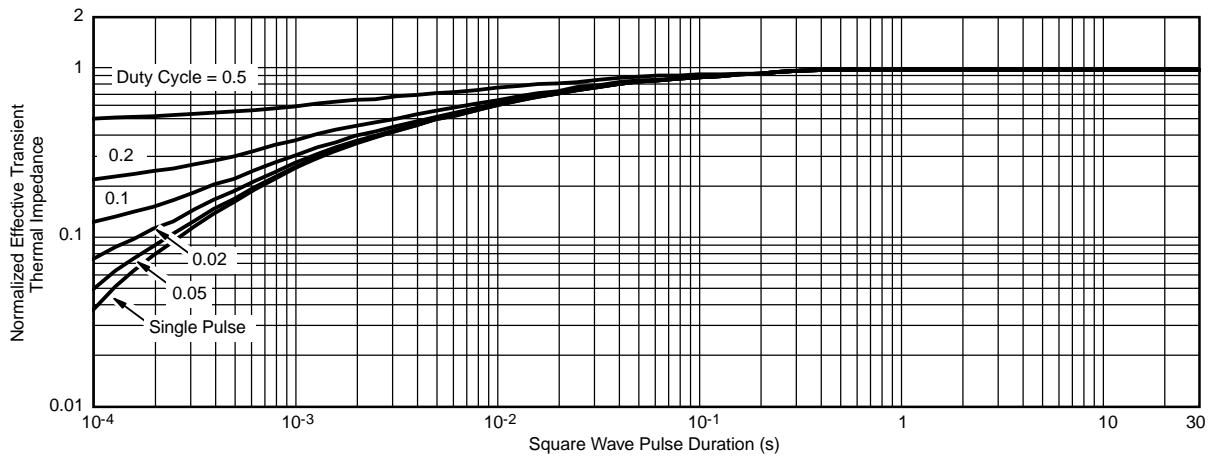

Single Pulse Avalanche Current Capability vs. Time

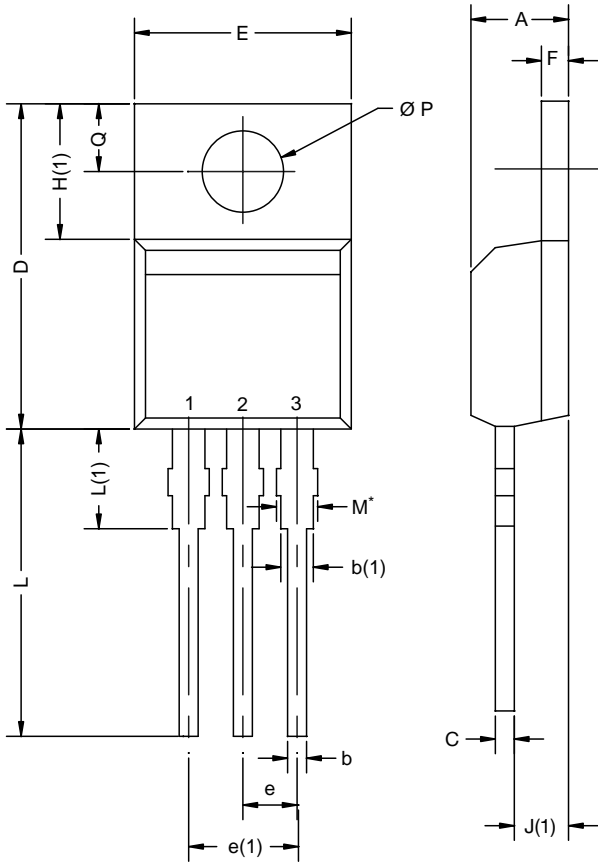
