




Gate Current vs. Gate-Source Voltage










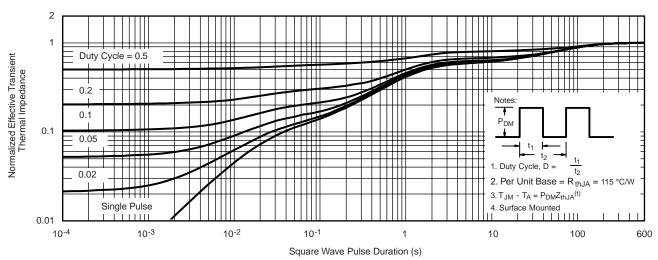

Safe Operating Area, Junction-to-Case









Normalized Thermal Transient Impedance, Junction-to-Foot






