






Transconductance






Transfer Characteristics




R_{DS(on)} vs. Drain Current








On-Resistance vs. Junction Temperature



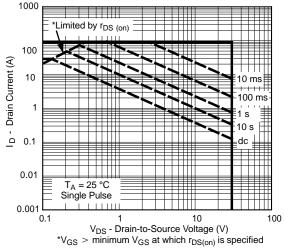
 $R_{DS(on)}\, vs.\, V_{GS}\, vs.\, Temperature$



Forward Diode Voltage vs. Temperature




Threshold Voltage






Normalized Thermal Transient Impedance, Junction-to-Case


