










On-Resistance vs. Drain Current




Gate Charge









On-Resistance vs. Junction Temperature













On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power (Junction-to-Ambient)



Safe Operating Area, Junction-to-Ambient








