




Source-Drain Diode Forward Voltage





Single Pulse Power (Junction-to-Ambient)








Normalized Effective Transient Thermal Impedance


## Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot


