






Source-Drain Diode Forward Voltage



Single Pulse Power








T_C - Case Temperature (°C)





THERMAL RATINGS ($T_A = 25$ °C, unless otherwise noted)




Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot
