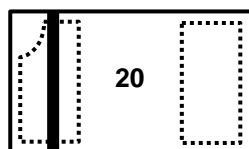

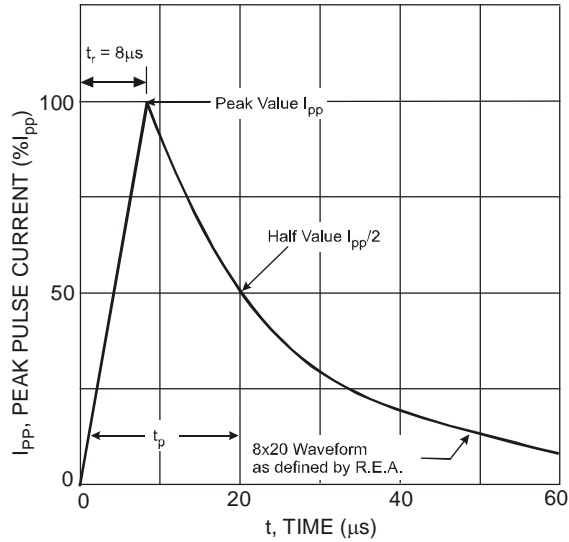


Figure 3 Typical 8 x 20µs Pulse Waveform

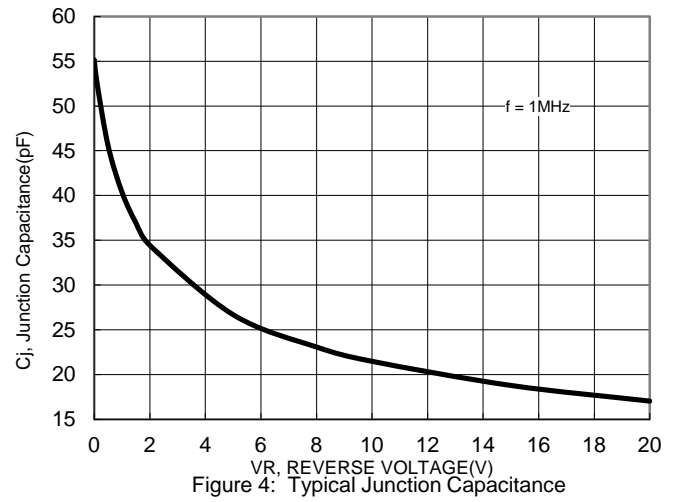


Figure 4: Typical Junction Capacitance

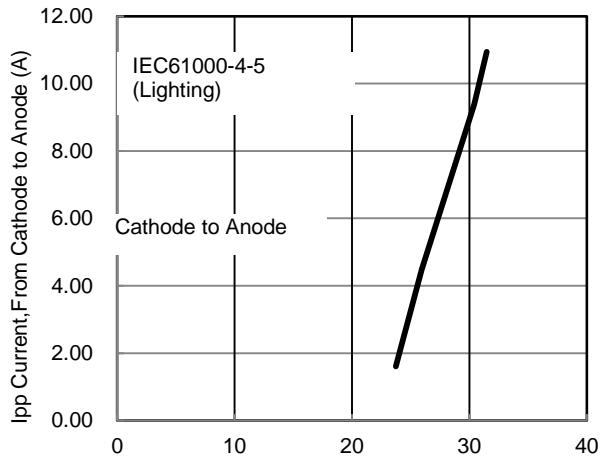
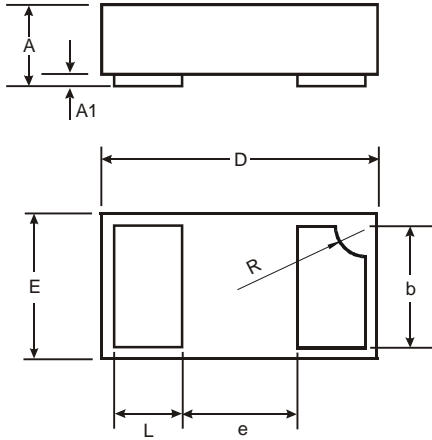


Figure 5 Clamping Voltage Characteristic

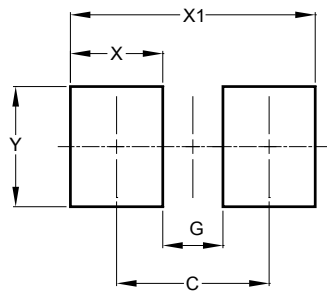
