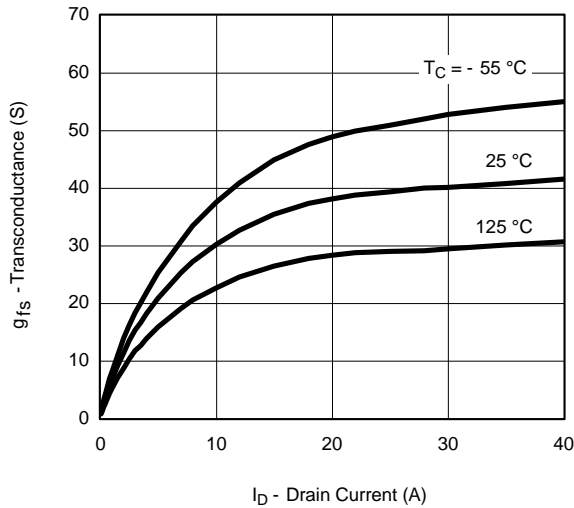

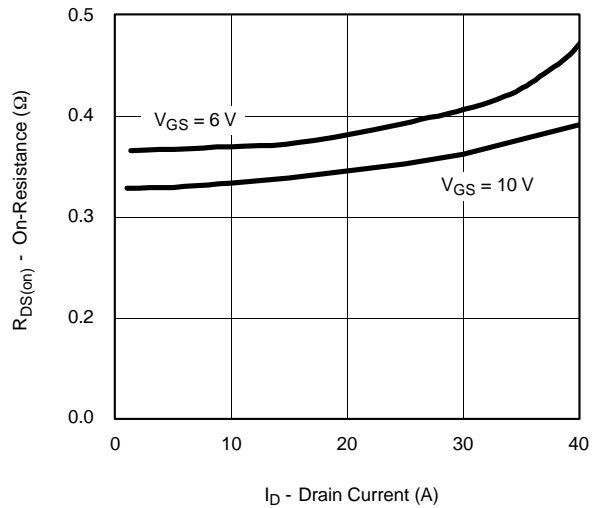

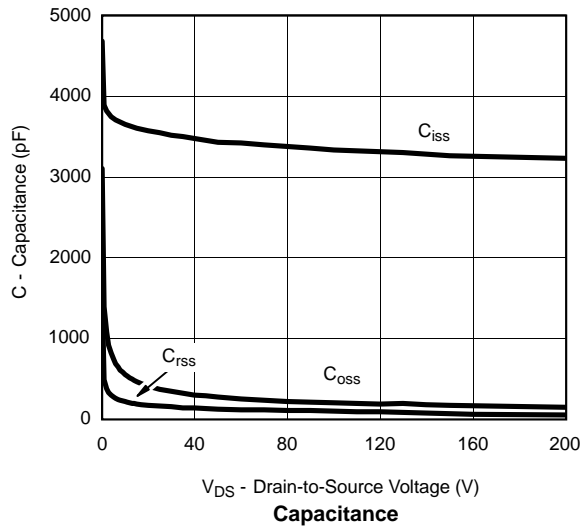

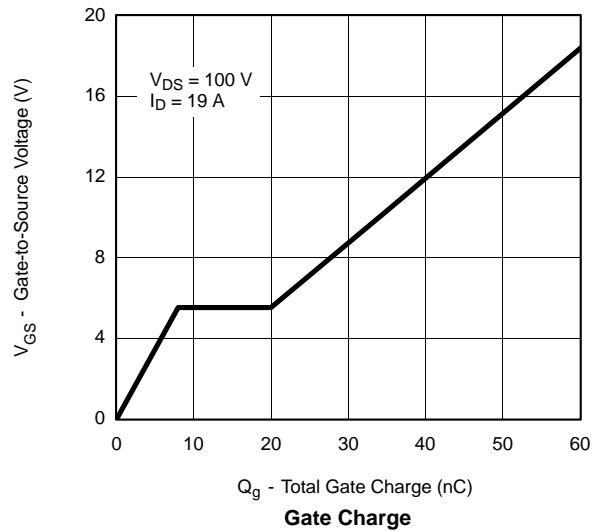

**On-Resistance vs. Junction Temperature**

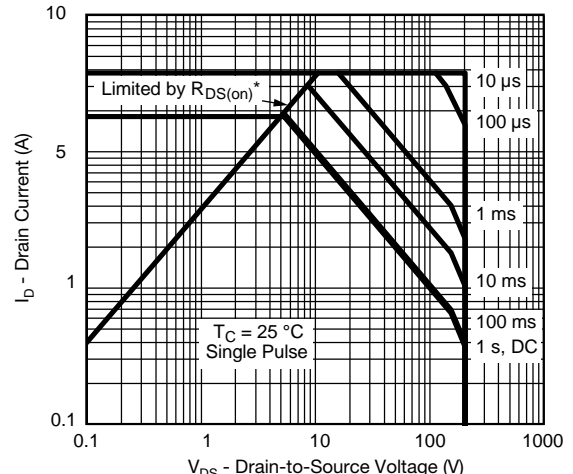


**Source-Drain Diode Forward Voltage**

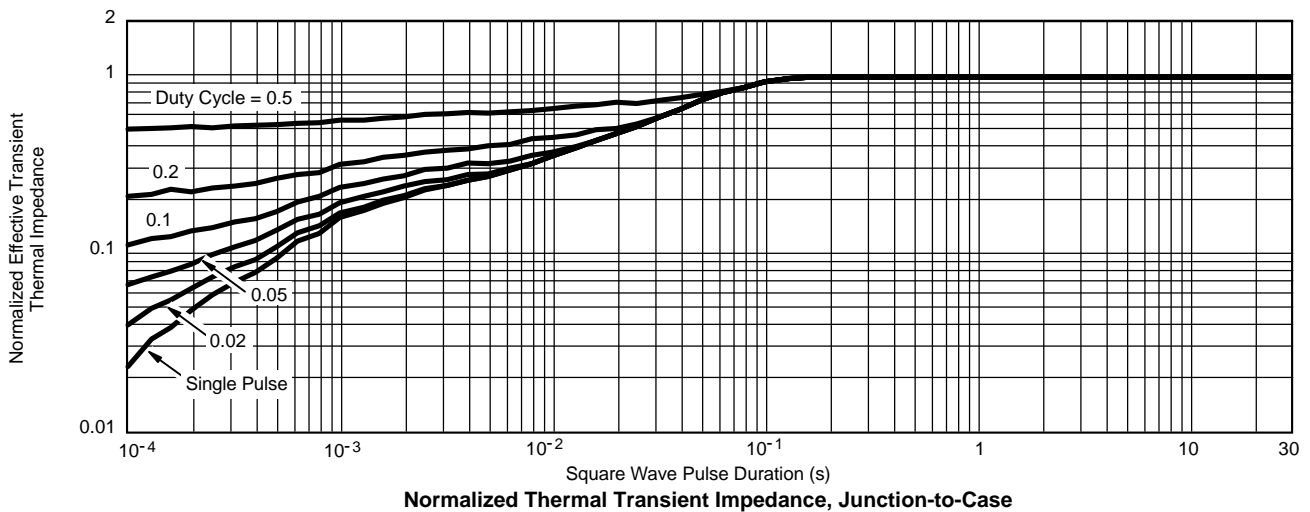

**Maximum Avalanche Drain Current vs. Case Temperature**

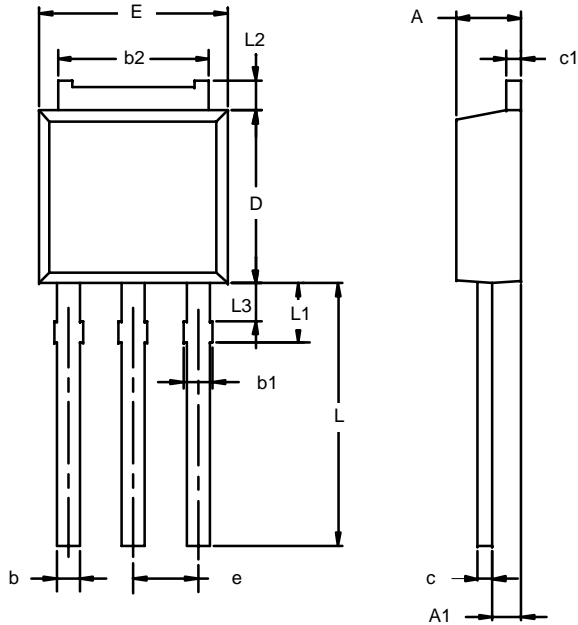


**Safe Operating Area**
