






#### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)



On-Resistance vs. Junction Temperature




Source-Drain Diode Forward Voltage


Maximum Avalanche Drain Current vs. Case Temperature


Safe Operating Area
