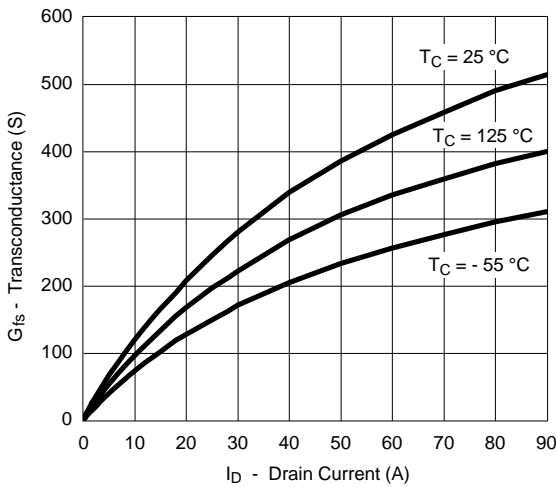

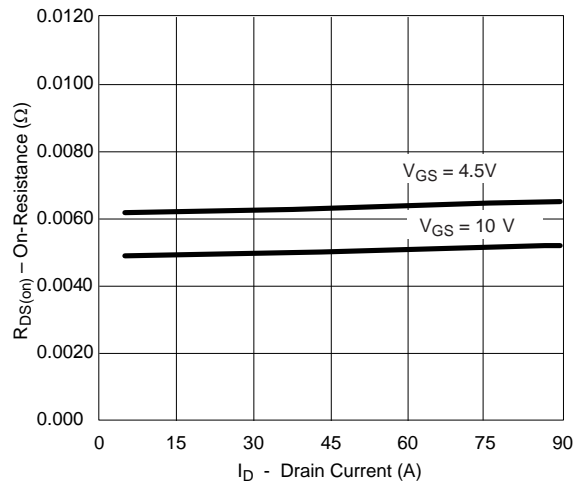

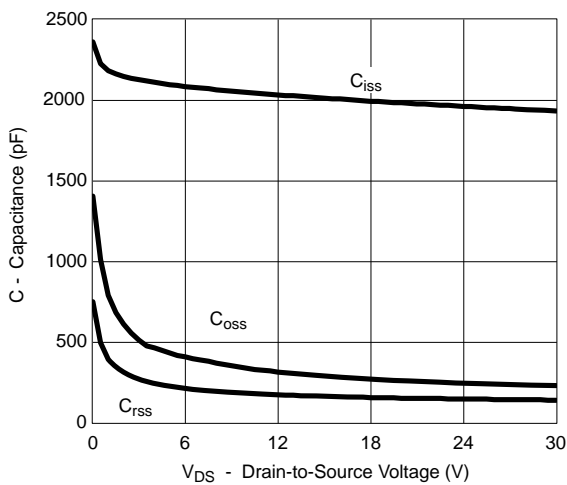

**$R_{DS(on)}$  vs. Drain Current**

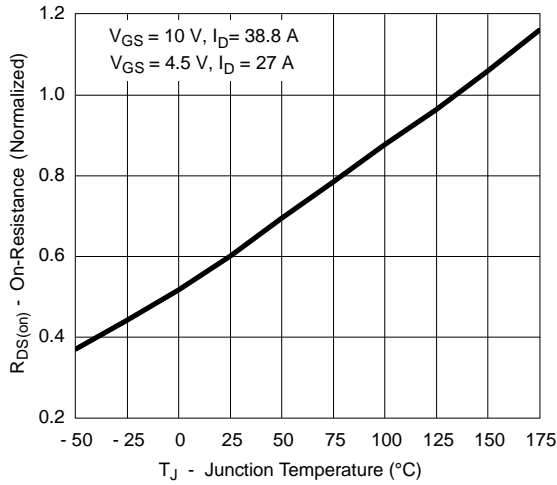


**Capacitance**

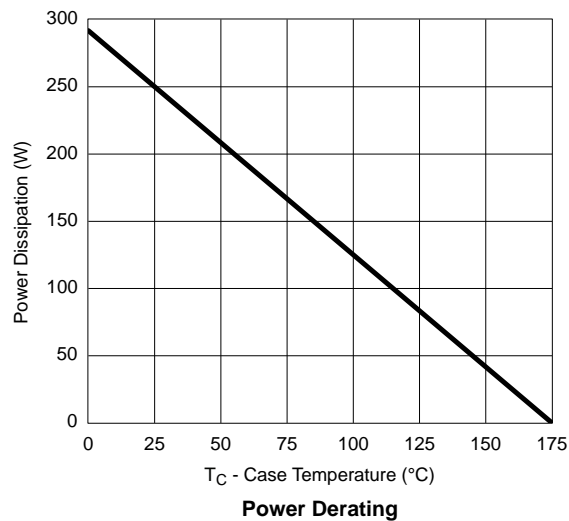
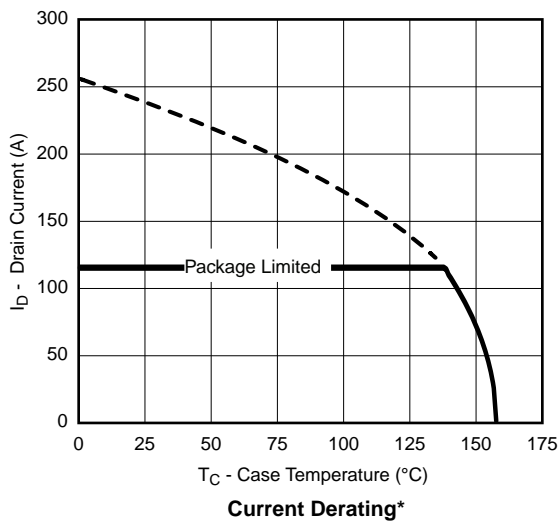

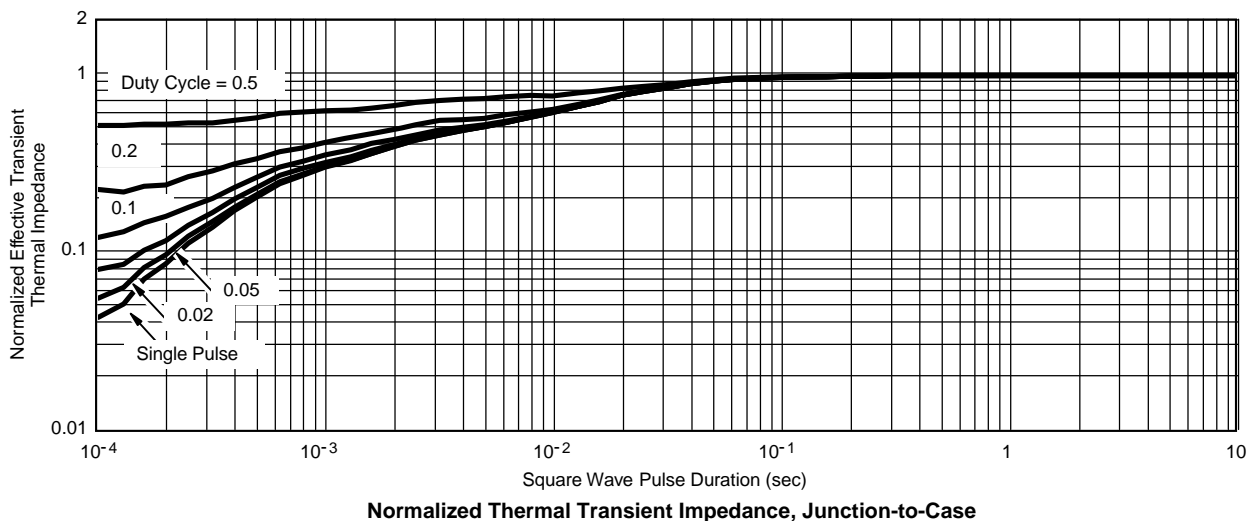
