




TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




On-Resistance vs. Junction Temperature

Current Derating



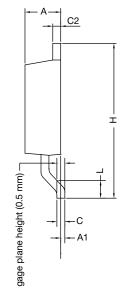


Square Wave Pulse Duration (s) Normalized Thermal Transient Impedance, Junction-to-Case

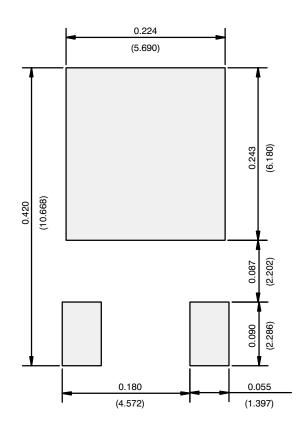
