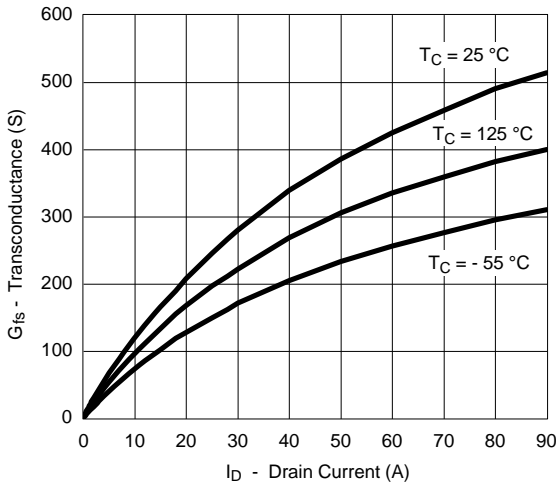

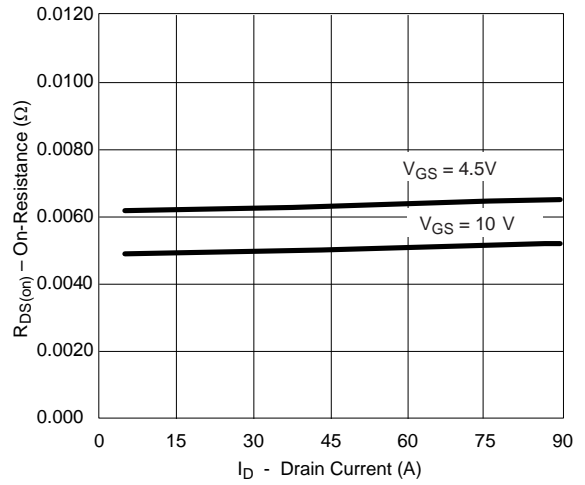

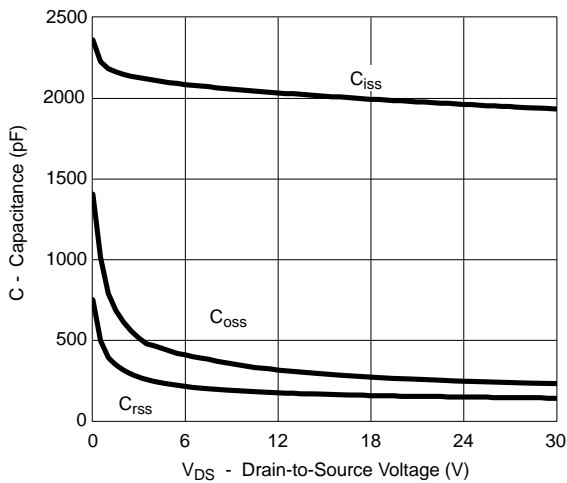
Transfer Characteristics

Capacitance

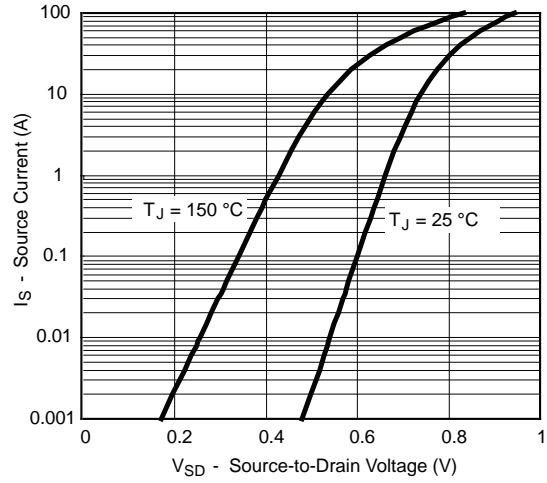

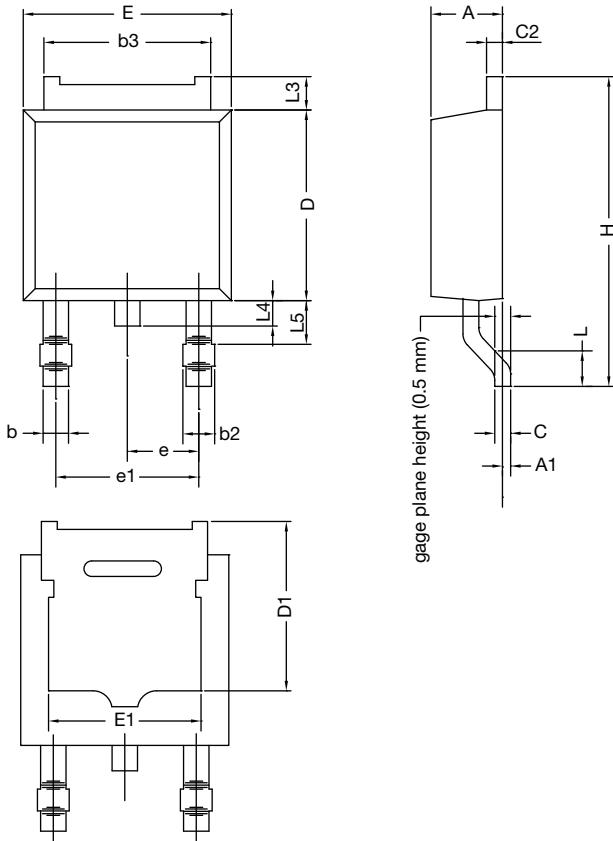

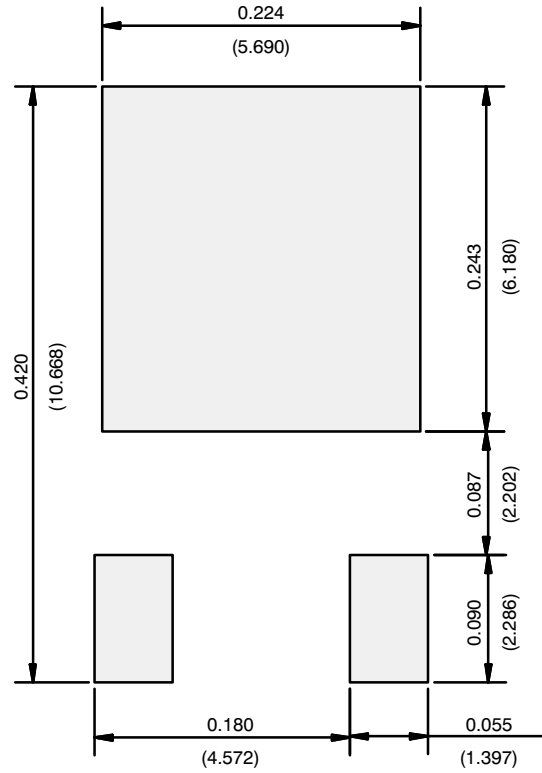
