



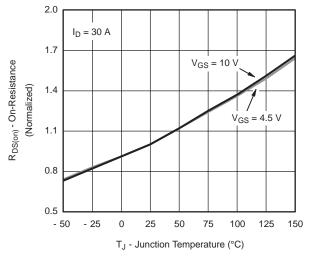


TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted








Threshold Voltage






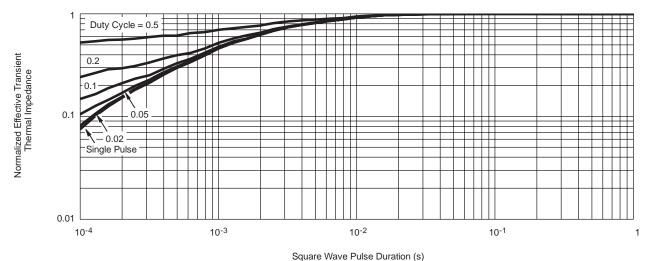






Normalized Thermal Transient Impedance, Junction-to-Case
