










Threshold Voltage



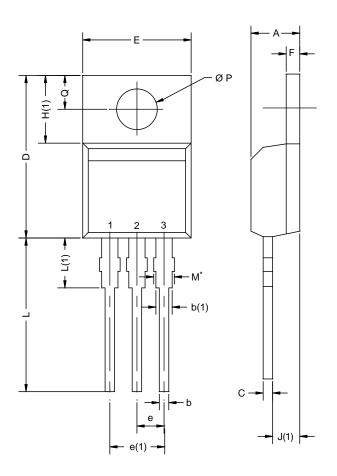
