
TYPICAL CHARACTERISTICS ($T_A = 25$ °C, unless otherwise noted)











On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage



Source Drain Diode Forward Voltage




Threshold Voltage




Drain Source Breakdown vs. Junction Temperature


Safe Operating Area




