




 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:Capacitance}$





Source-Drain Diode Forward Voltage





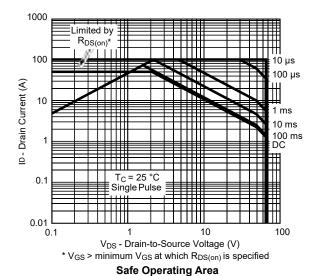

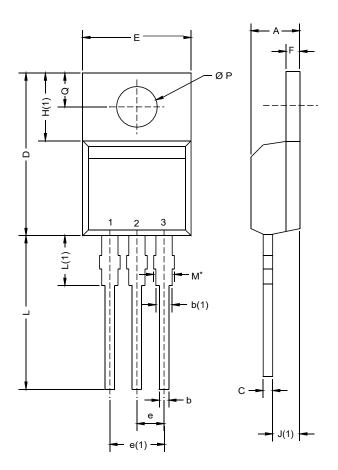
