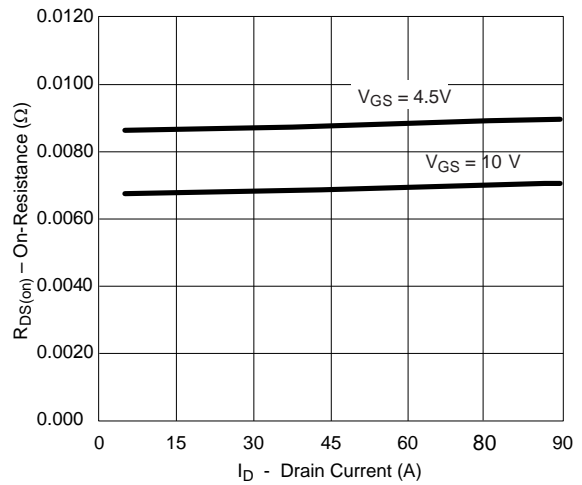

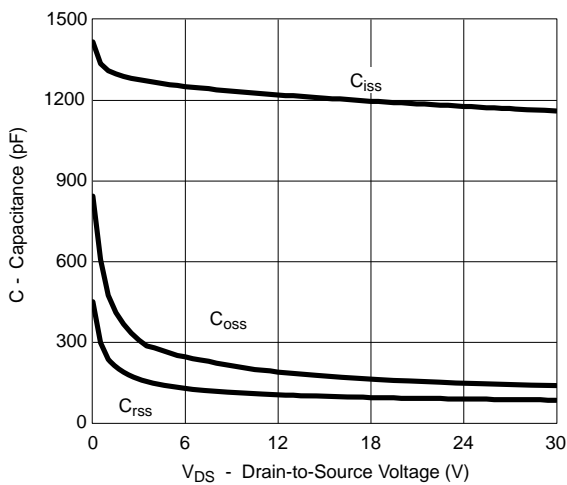

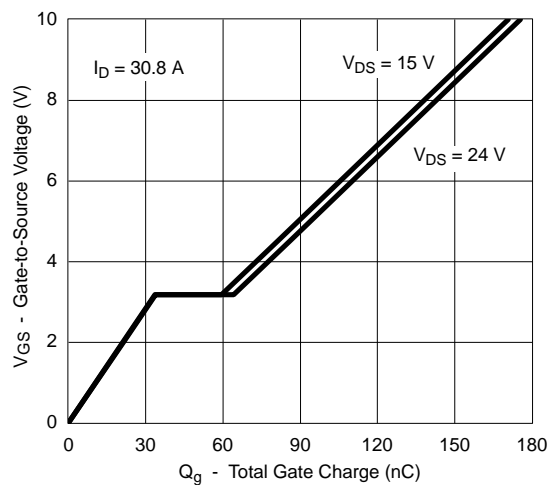

Capacitance

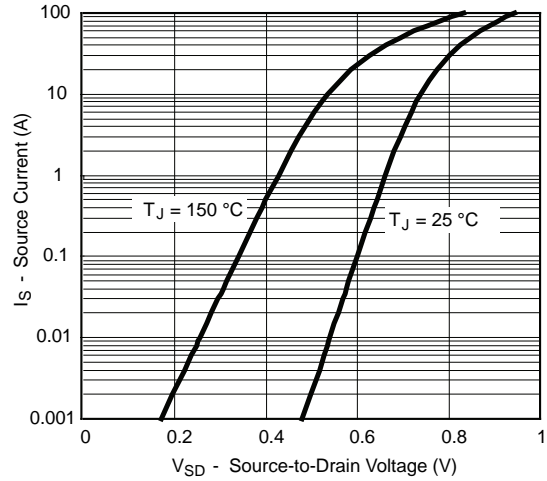
