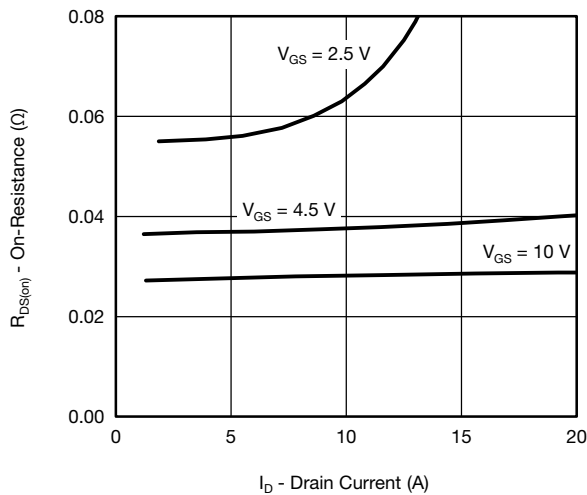

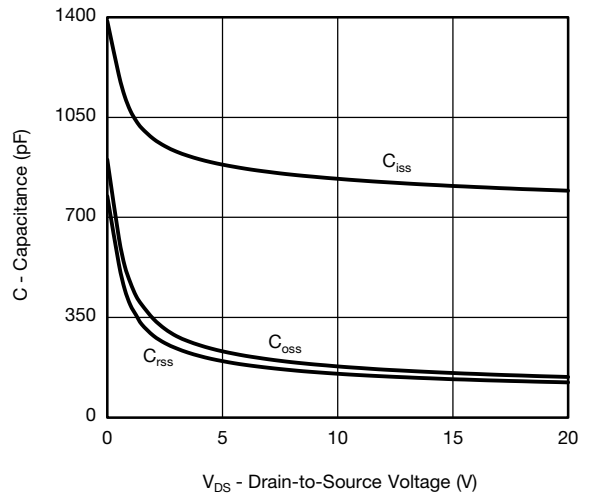
Output Characteristics

Capacitance

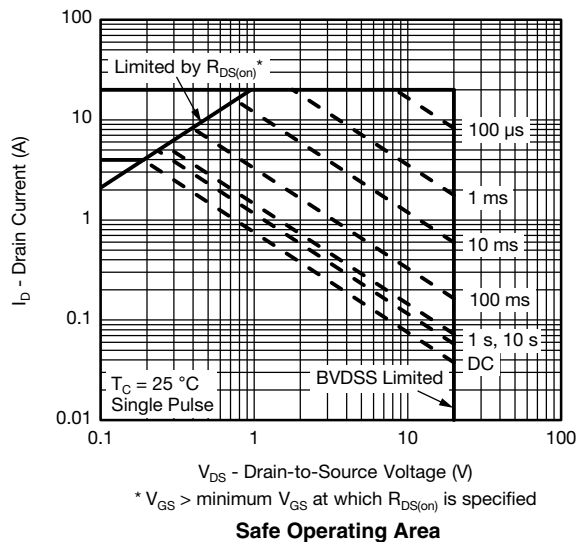
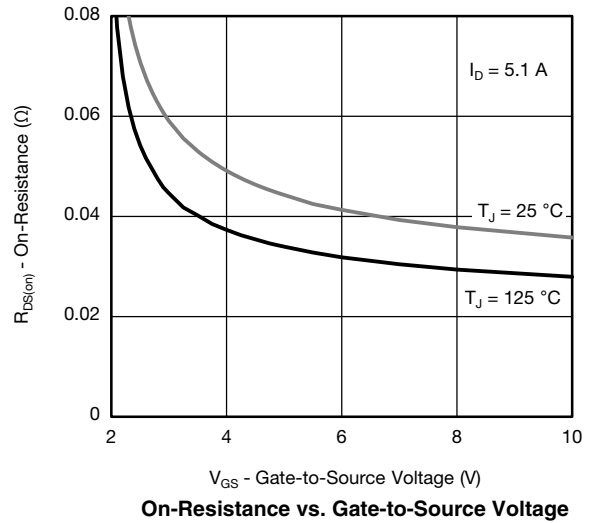


Gate Charge
