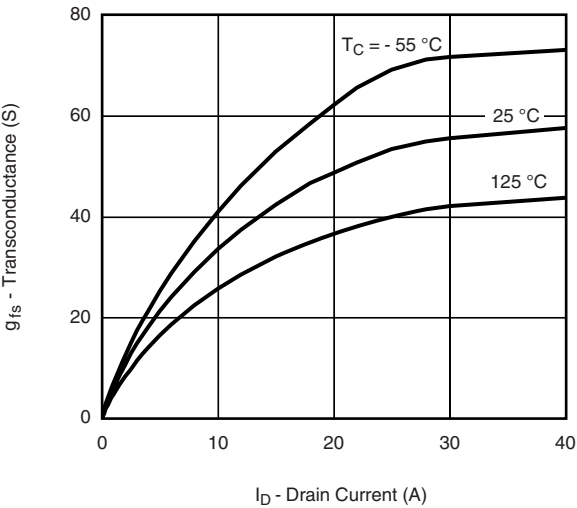

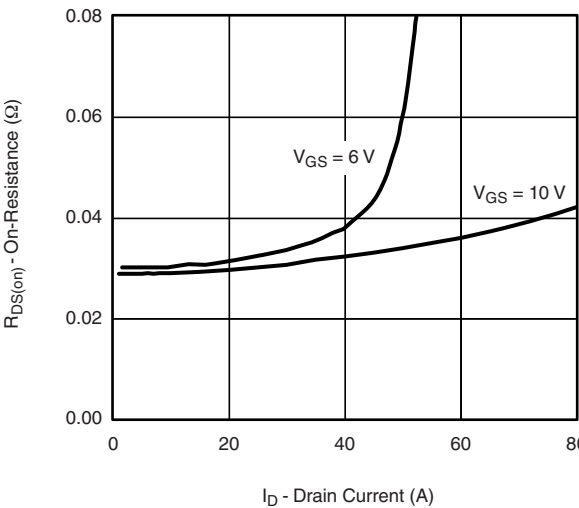

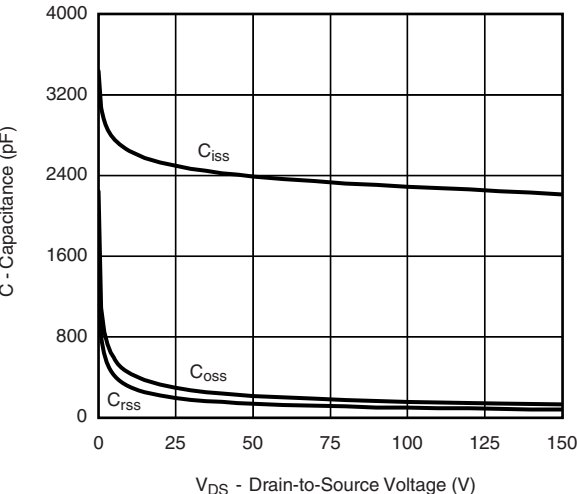

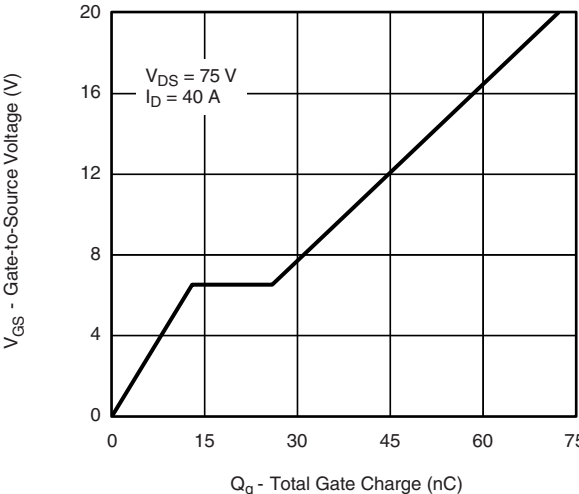
Transconductance



On-Resistance vs. Drain Current

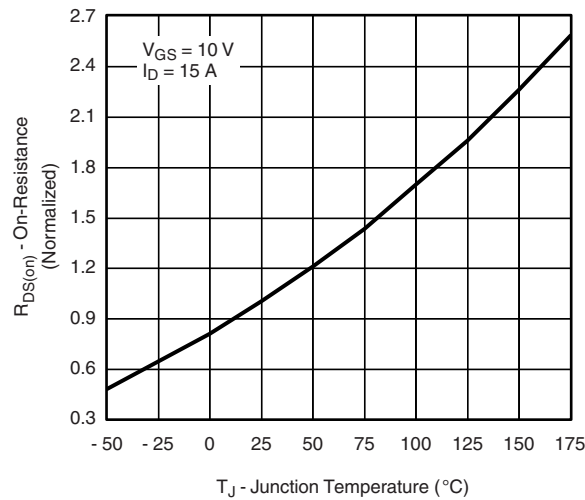

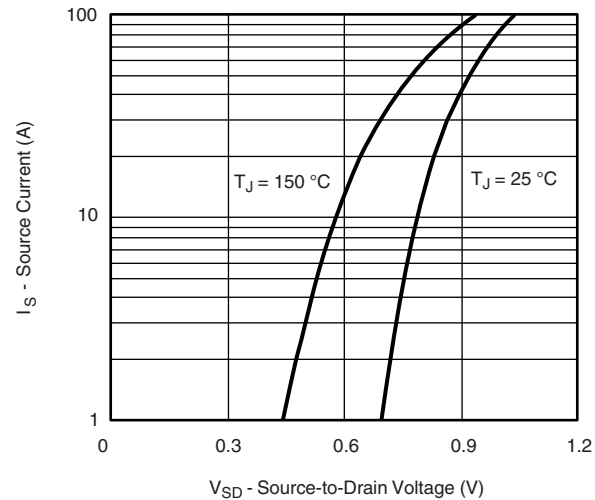

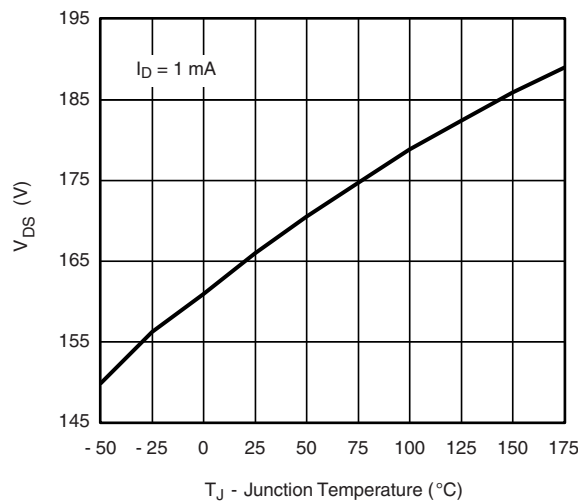

On-Resistance vs. Junction Temperature

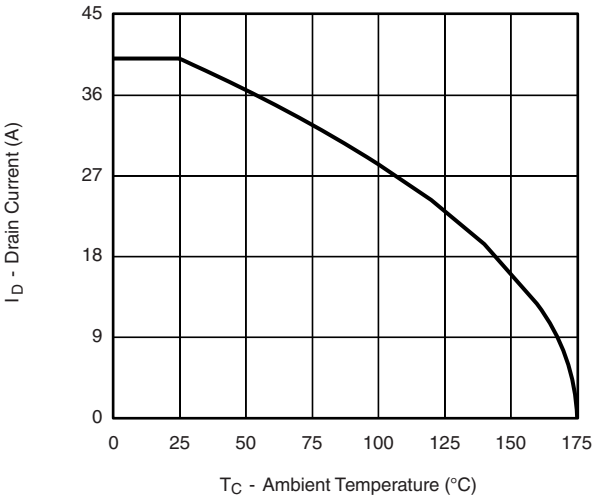


Source-Drain Diode Forward Voltage

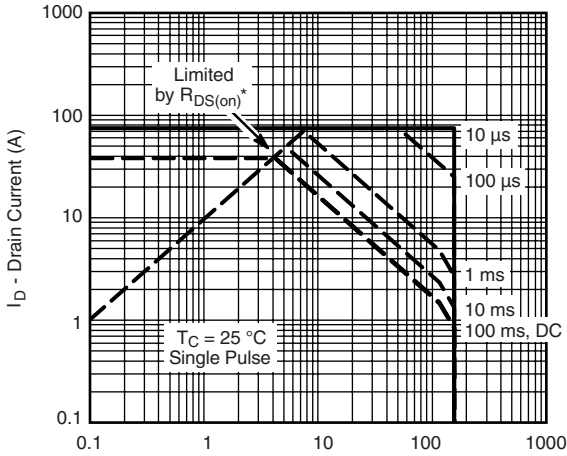


**Drain Source Breakdown
vs. Junction Temperature**

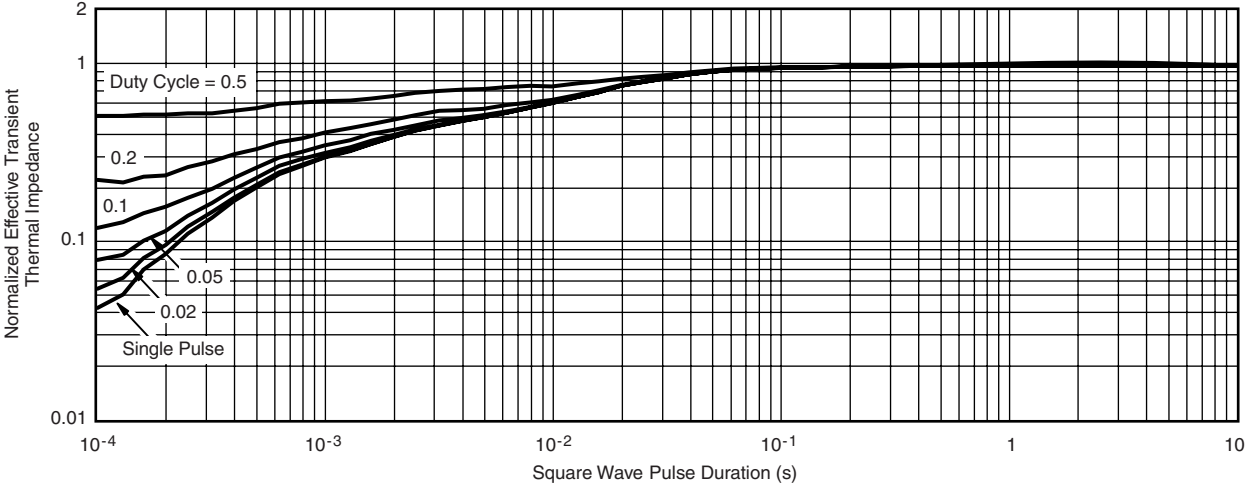

vs. Case Temperature

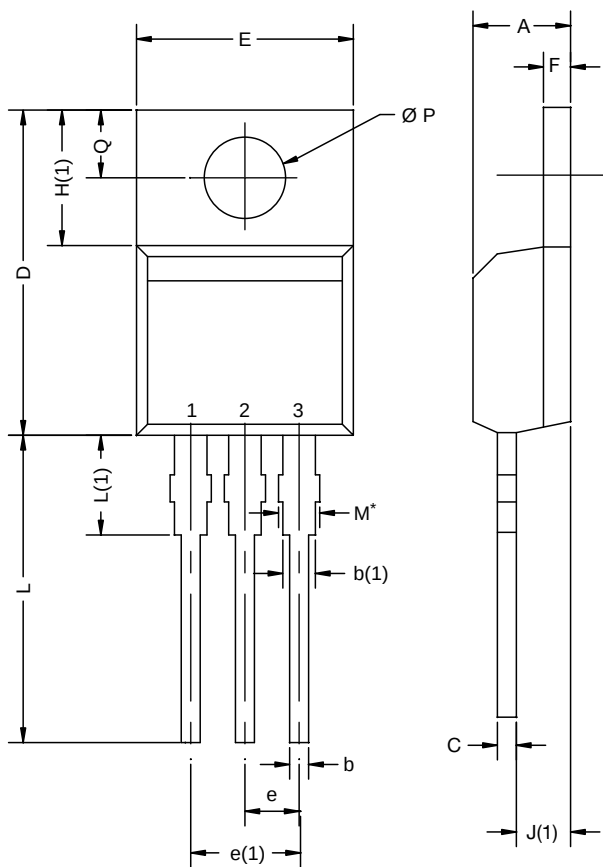
