# SKY12248-492LF: 2.3 to 4.2 GHz 120 W High-Power Single Pole, Double Throw (SPDT) Switch

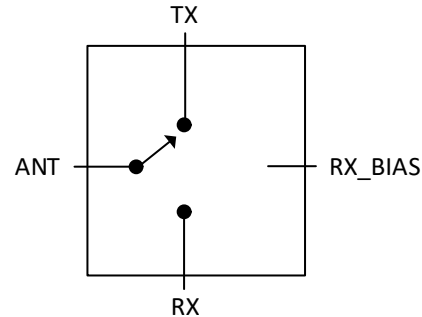

## Description

The SKY12248-492LF is an SPDT switch for TDD-LTE applications. The switch operates with both a 5 V supply and a 16 to 48 V supply. It can be tuned to specific RF bands within the range of 2.3 to 4.2 GHz by modifying select external surface mount technology (SMT) components.

The device features high-power handling, low TX and RX insertion loss, and high isolation with low dc power consumption. The device requires minimal external components, enabling a smaller PCB footprint.
